The kitchen is fitted with a range of cupboards, worktop surfaces and an integrated oven and hob. Finally, the shower room includes a double shower tray and glazed screen.

Access to the apartment is also particularly easy with the door to the lift being close to the apartment. There are, of course, stairs to all floors, for those who prefer the exercise, with only one flight of stairs being required for this apartment.

Communal services include: Lifts to all floors, residents house manager, 24 hour care line, pull cords in every room, a communal lounge and kitchen, a laundry room and scooter charging/parking. The guest suite can be booked by relatives and visitors. All the outside grounds are fully maintained and include a parking area.

Lacy Court residents must meet a minimum age criteria. A single occupant must be 60 or over and a couple must comprise one partner 60 or over with the second partner being at least 55 years of age. The lease length is 125 years from 2003. The service charge is approximately £2,785.85 for 6 months and a ground rent of £212.50 for 6 months.
