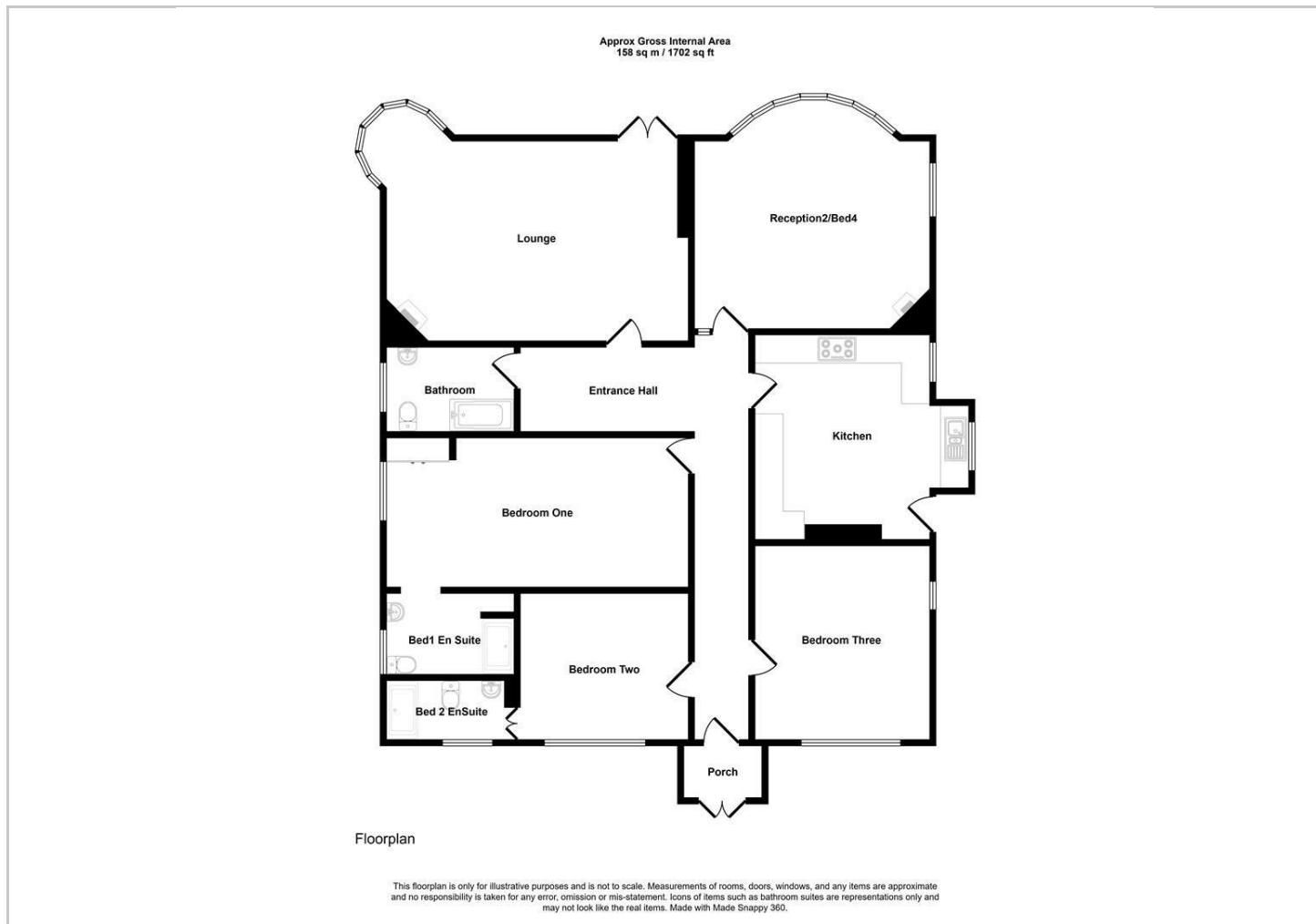

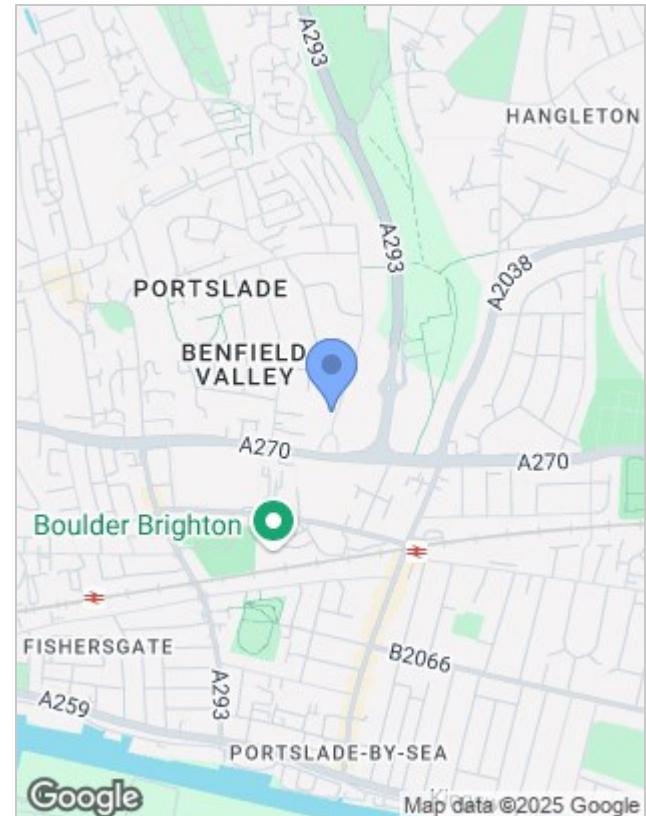




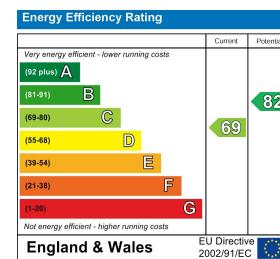
Floor Plans
