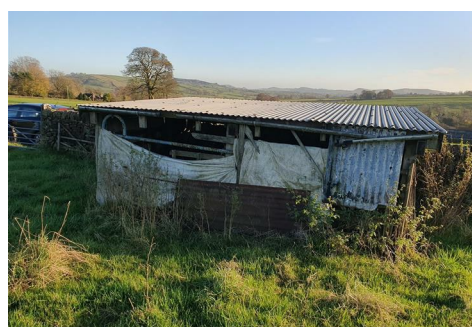

Directions

From our office on Derby Street, Leek, head north then turn right at the crossroads onto Buxton road (A53), continue for 5.3 miles. Turn right onto Leek road then continue for 4.2 miles. At the crossroads in Longnor turn left onto Buxton road (B5053), After 0.2 miles turn left onto Edge Top Road, the gateway is on the right roughly 0.2 miles after turning onto Edge top road.

Situation

The land is located on the outskirts of Longnor, approximately 6.6 miles from Buxton, 9.8 miles from Leek, 9.9 miles from Bakewell

Description

This is a parcel of permanent grassland which is relatively level in nature and is considered to be in good heart being laid to permanent pasture. The land extends to approximately 3.09 acres and include two timber and sheeted buildings with a catching and holding pen.

Services

We understand that this land is not connected to mains services.

Tenure and Possession

All of the land is freehold and vacant possession will be given on completion.

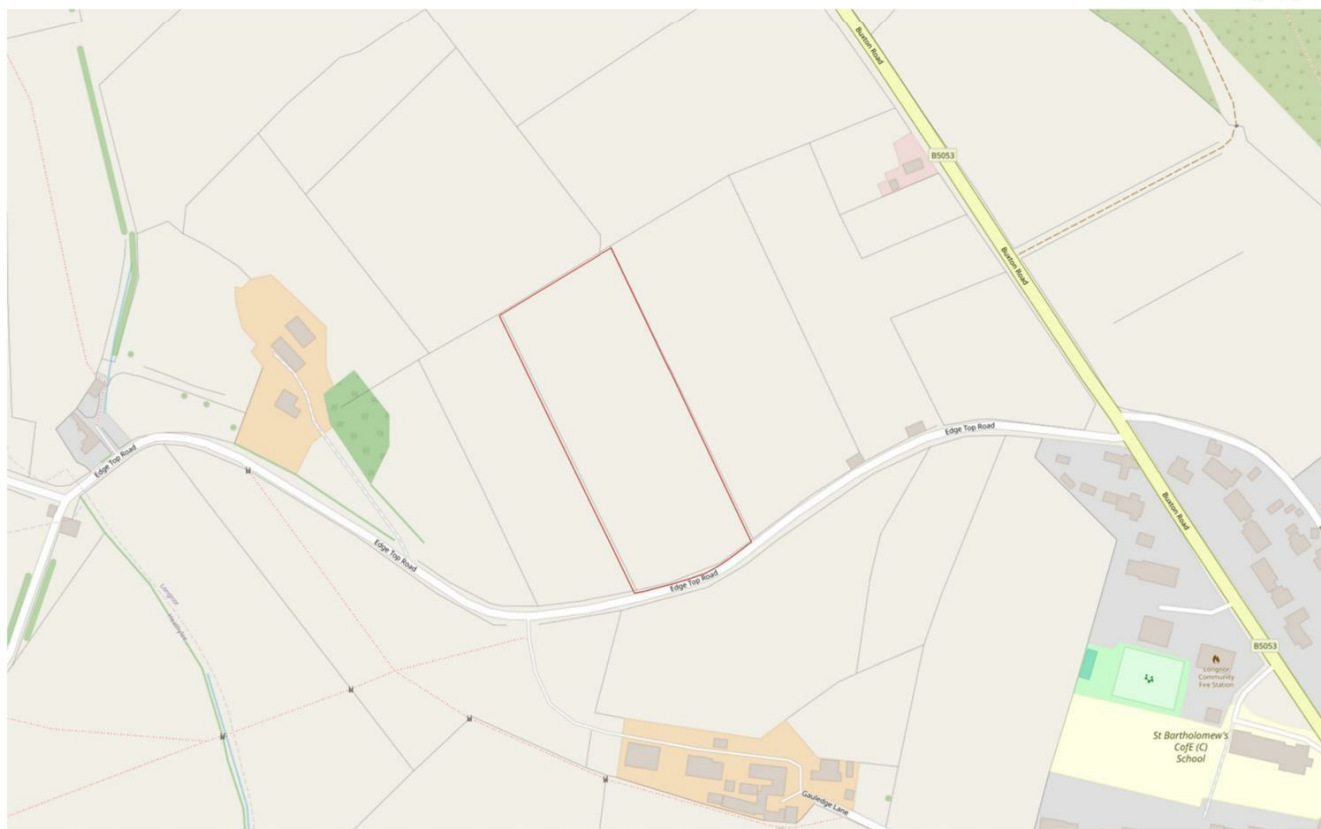

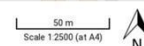

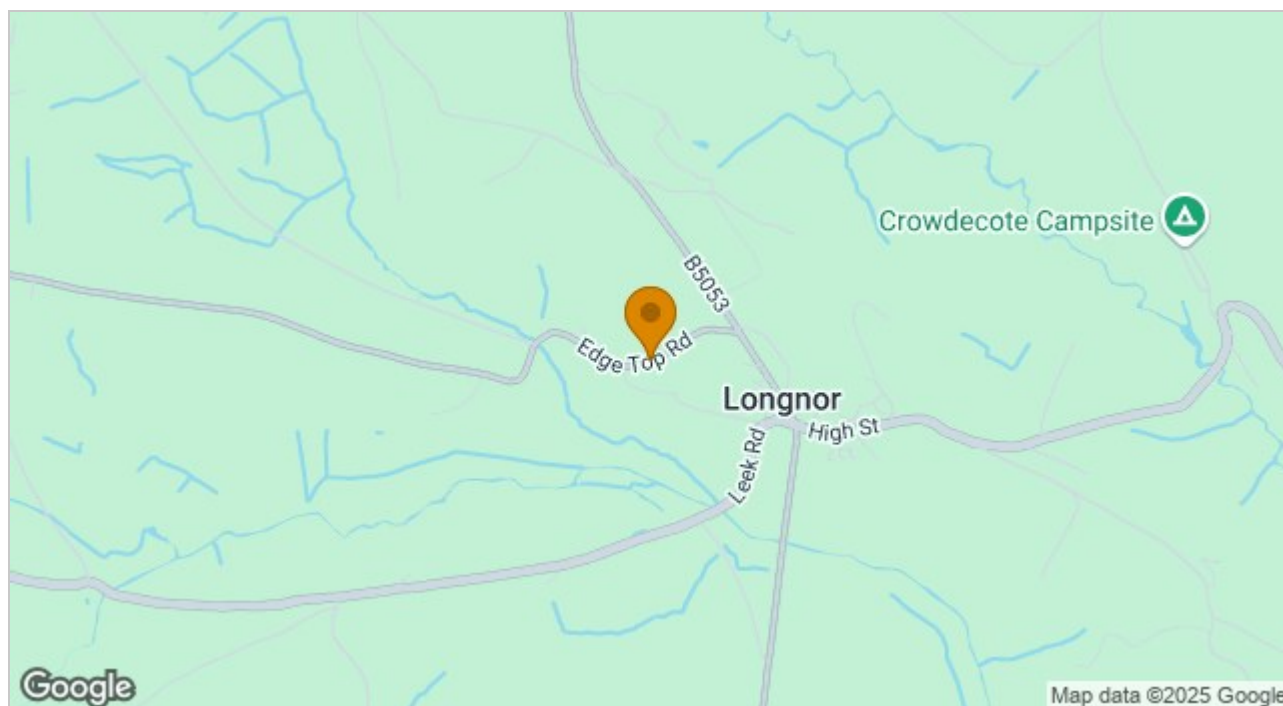
Plan
