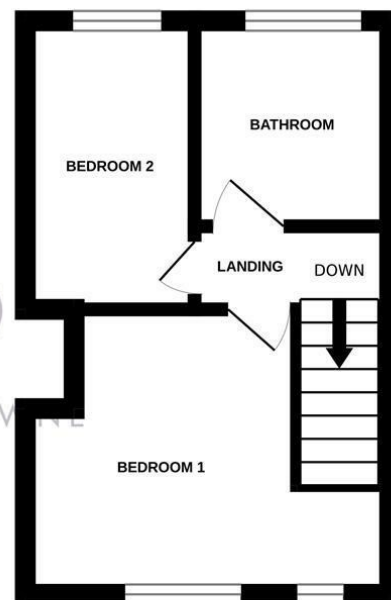




GROUND FLOOR
