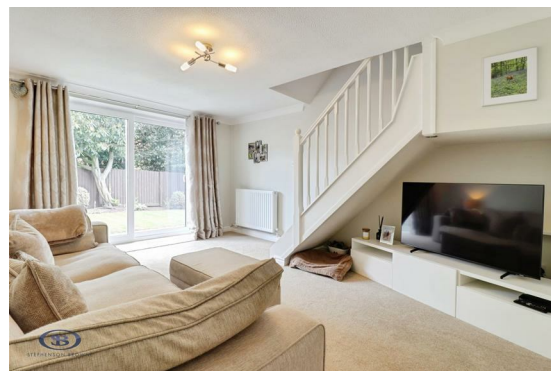
Situated on the popular Scott Close in Elworth, this well-presented two-bedroom home offers an ideal opportunity for first-time buyers and investors alike.

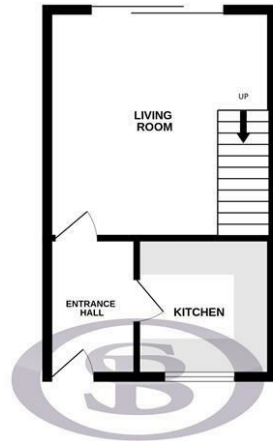

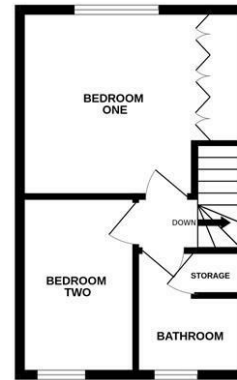


Floorplans
