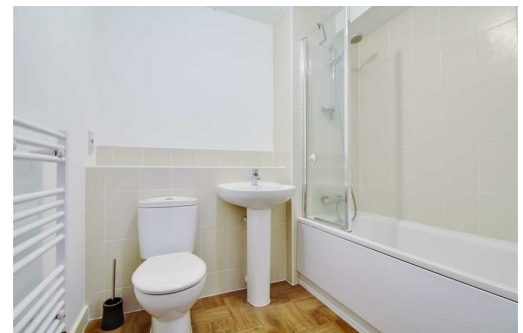

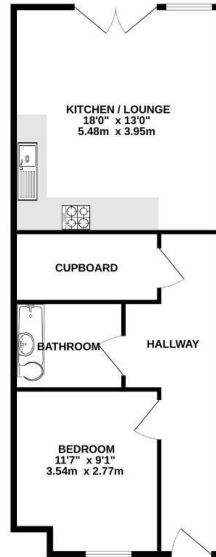

GROUND FLOOR

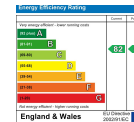
