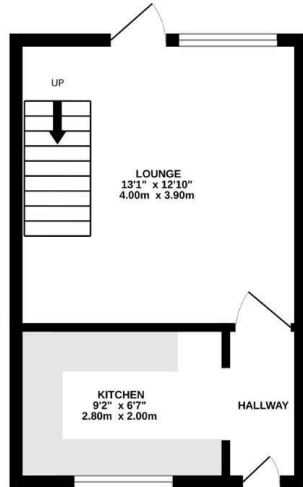

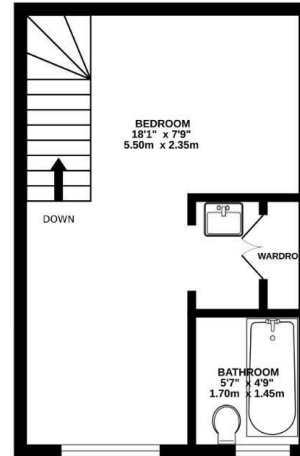

1ST FLOOR

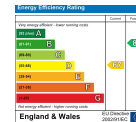

### Holding Deposit (per tenancy)

### Security Deposit (per tenancy. Rent under £50,000 per year)

**Five weeks' rent.**

**Six weeks' rent.**

### Unpaid Rent
