





### Holding Deposit (per tenancy)

**One week's rent.** This is to reserve a property. Please Note: This will be withheld if any relevant person (including any guarantor(s) withdraw from the tenancy, fail a Right-to-Rent check, provide materially significant false or misleading information, or fail to sign their tenancy agreement (and / or Deed of Guarantee) within 15 calendar days (or other Deadline for Agreement as mutually agreed in writing).

### Security Deposit (per tenancy. Rent under £50,000 per year)

**Five weeks' rent.** This covers damages or defaults on the part of the tenant during the tenancy.

### Security Deposit (per tenancy. Rent of £50,000 or over per year) during the tenancy.

**Six weeks' rent.** This covers damages or defaults on the part of the tenant during the tenancy.

### Unpaid Rent

Interest at 3% above the Bank of England Base Rate from Rent Due Date until paid in order to pursue non-payment of rent. Please Note: This will not be levied until the rent is more than 14 days in arrears.
