Entrance Hall

Accessed via the front door is the hallway which has wooden flooring, airing cupboard and doors leading off to the accommodation.

Living Room

A light and bright room with a fireplace with brick and wooden surround and inset gas fire, feature stained glass window wooden flooring and doors leading out to the balcony.

Bedroom One

Generous double room with large walk in wardrobe and window to rear aspect overlooking the garden.

Bedroom Three

Currently utilised as office space with wooden flooring and window to the front aspect.

Bathroom

Suite comprising bath, WC and wash basin with frosted window to the front.

Kitchen/Diner

A range of base and wall mounted units with laminate work surfaces, one and a half bowl stainless steel sink unit, space for appliances, tiled flooring, window to the front aspect and door to rear lobby/utility.

Rear Lobby/Utility

Plumbing for washing machine, shelved storage space and doors leading off.

Bedroom Two

A pleasant and light room with window to the side aspect and double doors out to the balcony.

With fully tiled floor, electric shower, WC and wash basin.

UPVC construction give a handy side entrance into the lobby from gardens.

To the front of the property is a lawn with mature hedgerow with two paths leading to the front door. One from the path and one leading from the driveway which has parking for two vehicles and leads to a single garage. The rear garden is mainly laid to lawn with established shrubs, borders and trees. There is a patio area and steps up to a balcony ideal for alfresco dining! There is also some crawl space storage under the bungalow.

The market town of Newent sits 8 miles north west of Gloucester, on the northern edge of the Forest of Dean. 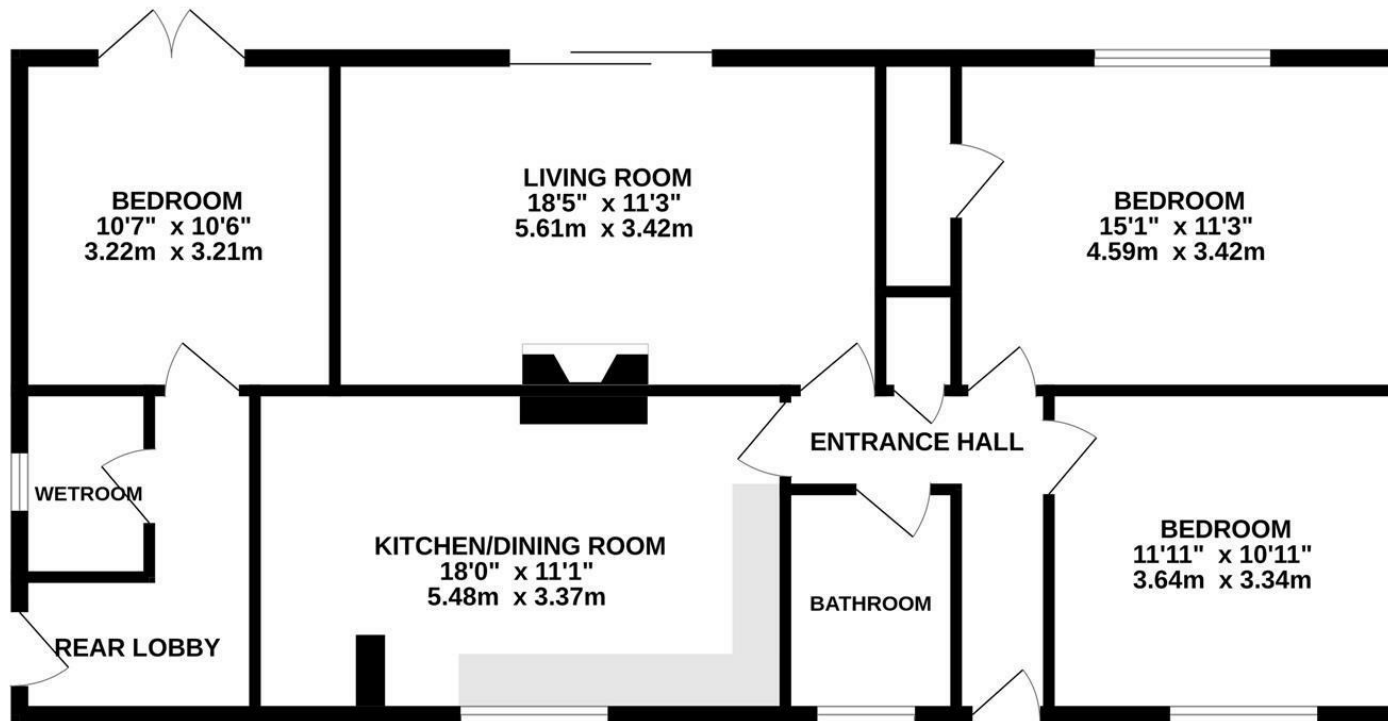

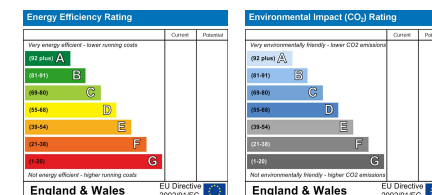
