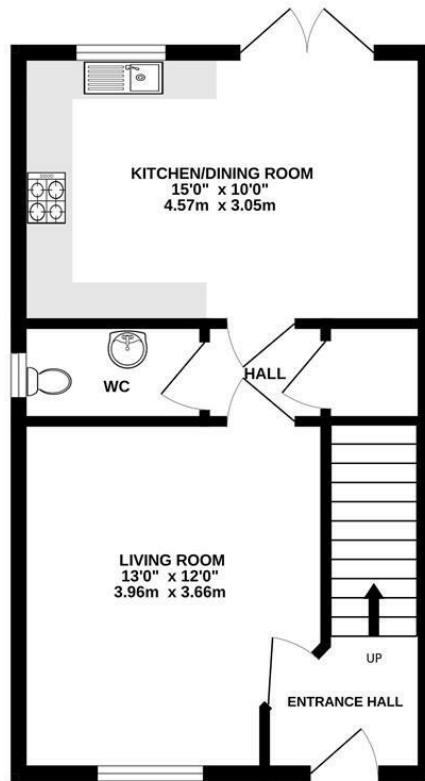

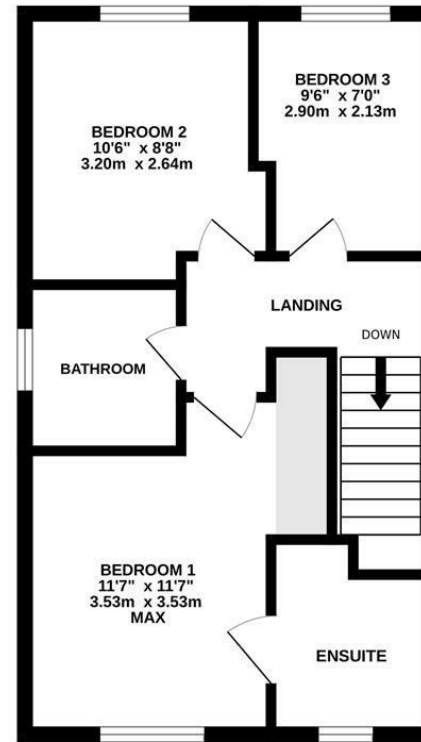




GROUND FLOOR
