## DESCRIPTION

A mixed-use property arranged as a ground floor takeaway (with basement storage), with a first floor self-contained 2 bedroom flat, and further 3 bedroom self-contained HMO. The flats are let producing a gross annual rent of £43,365pa and the takeaway will be offered for sale with vacant possession and could therefore suit an owner occupier. However, once fully let, we would anticipate a total gross rent of circa £67,000pa. The flats are let to students on Assured Shorthold Tenancy agreements and benefit from both gas central heating and upvc double glazing.

## LOCATION

The property is situated in a highly prominent trading position towards the top end of Whiteladies Road, Clifton.

## ACCOMODATION

The ground floor is arranged as a takeaway with commercial extraction and a large basement providing ancillary storage. The flats are both self contained with gas central heating. Please refer to the floor plan for the layout.

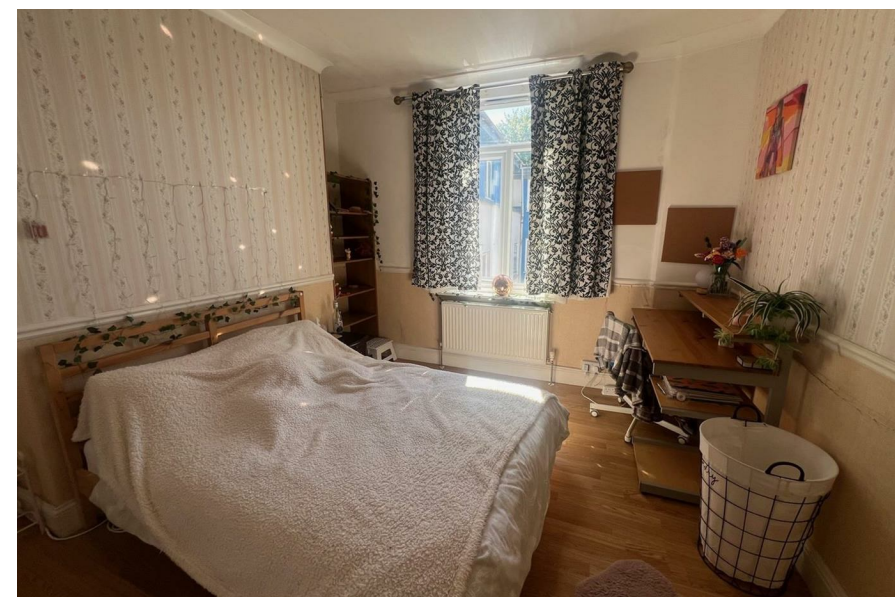
