DESCRIPTION

Ground floor retail unit extending to approximately 464 sq ft (43.1 sq m), arranged primarily as open plan shop space, offering a flexible layout suitable for a variety of commercial uses. The unit also benefits from rear storage area and a WC. The premises would be ideal for businesses within Use Class E — which includes retail, office, café and other commercial uses, subject to consent.

LOCATION

The property enjoys a highly visible corner position on Stockwell Drive, in the popular area of Mangotsfield.

BUSINESS RATES


