A mid terrace, two storey shop let to an established tenant at £32,000pa. The shop is located on the High Street but also backs onto the Station Road Car Park. The ground floor is well presented, measuring approximately 920 ft², while the first floor provides additional ancillary storage, treatment rooms, kitchen and toilet, measuring approx. 425 ft². The property is let on a 10-year fully repairing and insuring basis from March 2021 with no break clause. The first floor and rear of the property also offer long term potential for redevelopment subject to obtaining the necessary consents and vacant possession.

The property is situated on the High Street in Nailsea within close proximity to Waitrose supermarket.

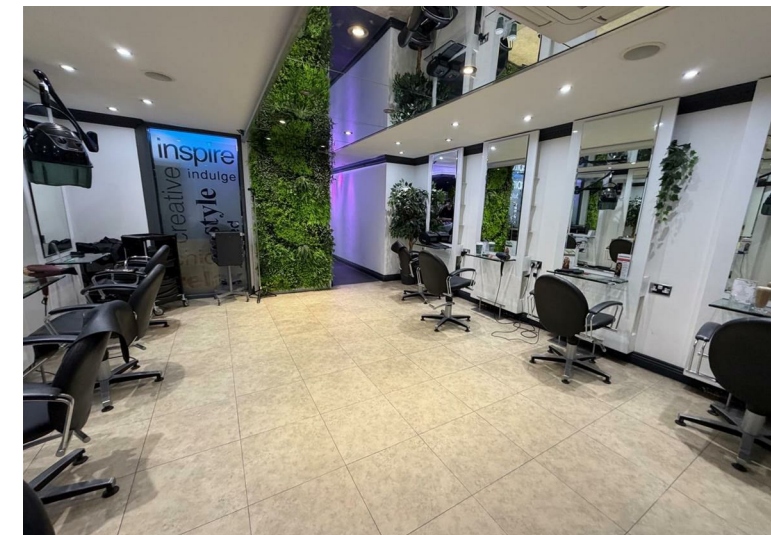
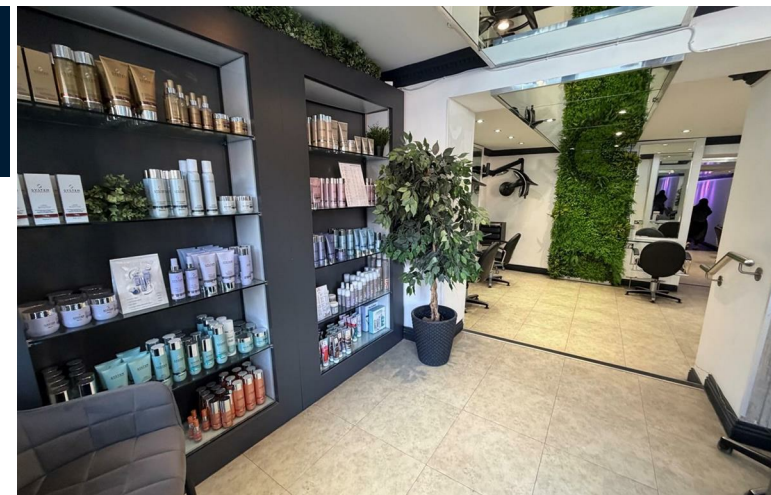
PROXY, TELEPHONE & ONLINE REMOTE BIDDING

The Preliminary Deposit required for each lot you wish to bid for is £5,000.

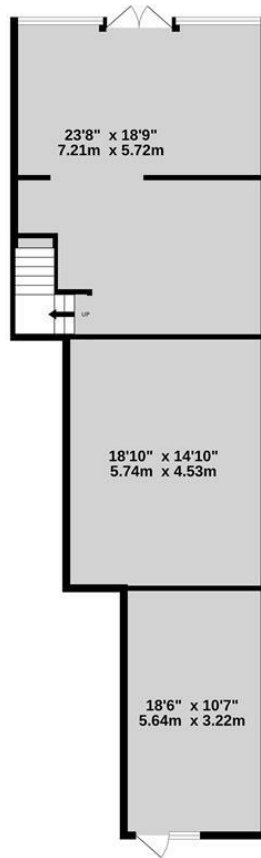

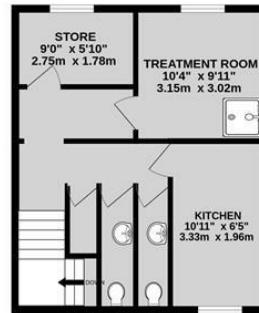
