SUBSTANTIAL FORMER SCHOOL ON A 0.42 ACRE SITE WITH REDEVELOPMENT POTENTIAL

DESCRIPTION

A substantial site of approximately 0.42 acres (1,700 sq m) occupied by an attractive former school of over 10,600 sq ft (GIA) / 8,000 sq ft (NIA) with additional outbuildings and grounds to the sides and rear. The site offers significant potential for residential redevelopment - either by demolishing or converting the existing building, subject to obtaining all necessary consents. The existing building is in need of full refurbishment and is arranged over two floors comprising various classrooms/meeting rooms around a large central hall with additional kitchen and toilet facilities.

LOCATION

The property is situated on Queen Ann Road, Barton Hill just off St Philips Causeway within approximately 1 mile of Bristol City Centre. Bristol Temple Meads and Lawrence Hill train stations are both less than a mile away and easy access is provided to the A4 Bath Road.






