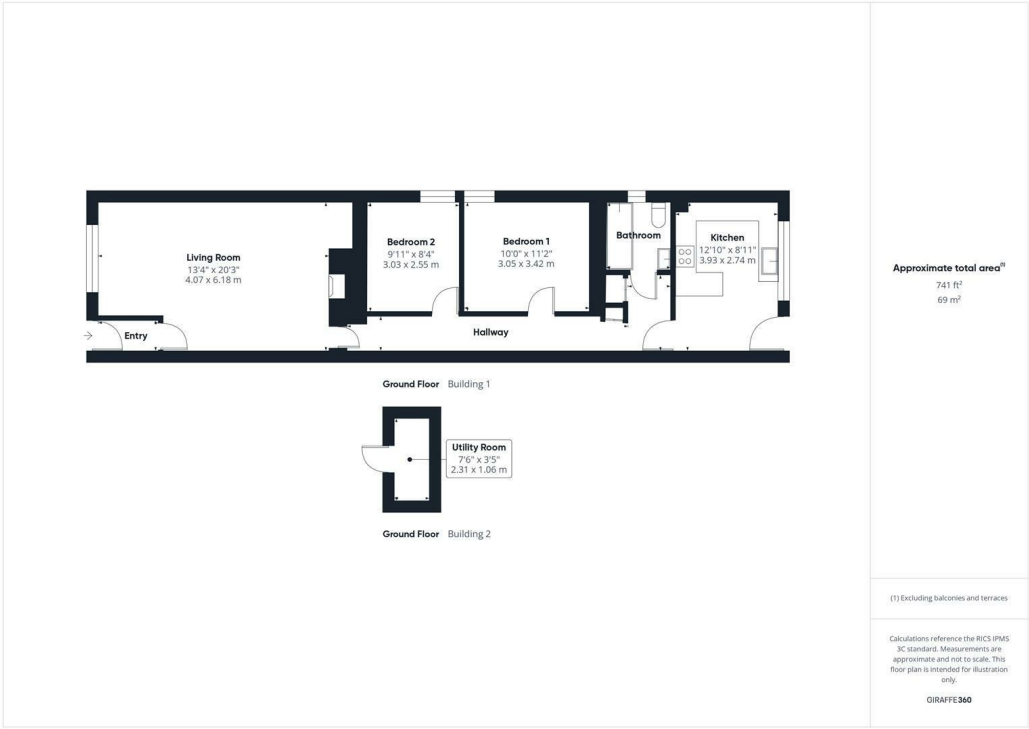

A well presented two bedroom bungalow offering spacious and versatile accommodation throughout. The property comprises two generous double bedrooms, a bright and airy living/dining room, a fitted kitchen/breakfast room, and bathroom.

Externally, there is a private, level and low maintenance courtyard garden with a useful external storage area. To the rear, a private lane accessed from Southmead Road leads to an off street parking area for two vehicles. Ideally located for local amenities on Southmead Road and Henleaze Road, the property is just a stone's throw from Southmead Hospital with excellent bus links.

LOCATION

This is a very convenient location. Southmead Hospital is 0.3 miles away, Henleaze High Street is around a 15 minute walk and Westbury Village is less than a mile away. At the end of the road there is Henleaze Swimming Lake and Badocks Woods is great for walking the dog. Close by is BAWA Sports Ground, David Lloyd Health Centre, and Horfield Leisure Centre. There are excellent bus links to all parts of the city and its only a short drive to Cribbs Causeway and the motorway network.
