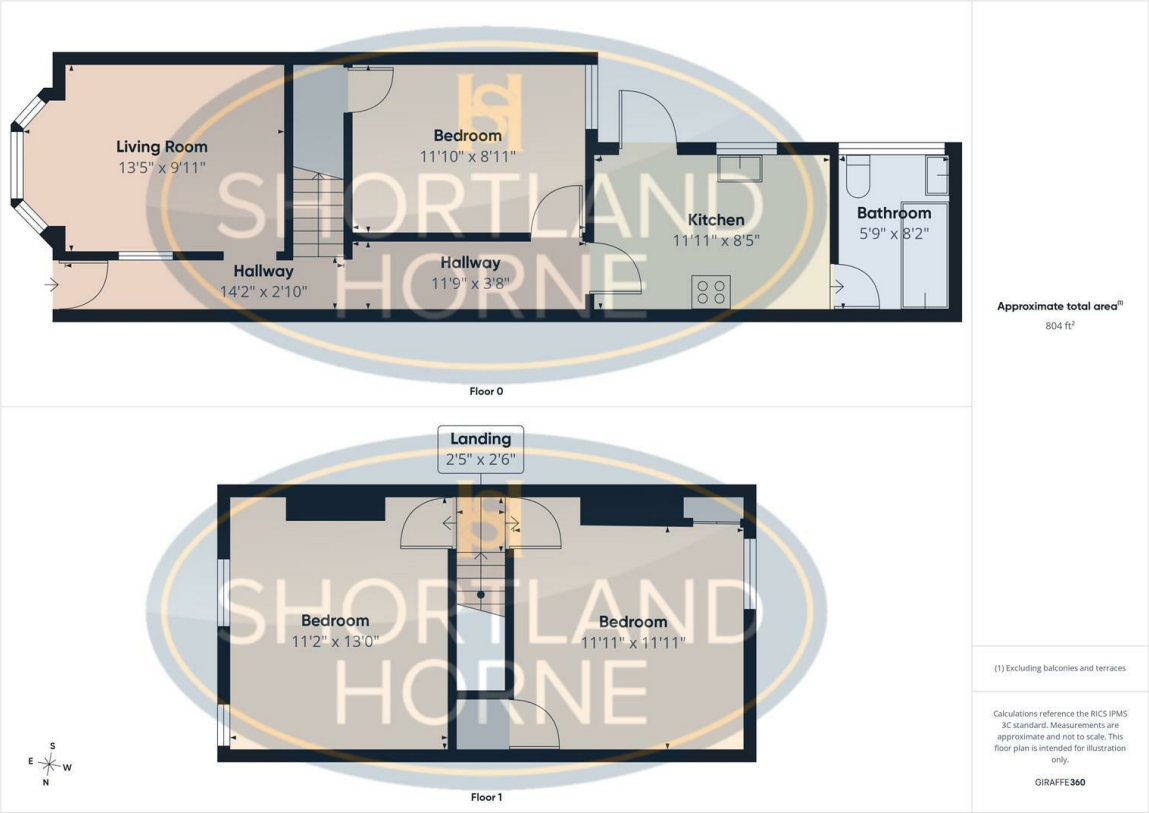




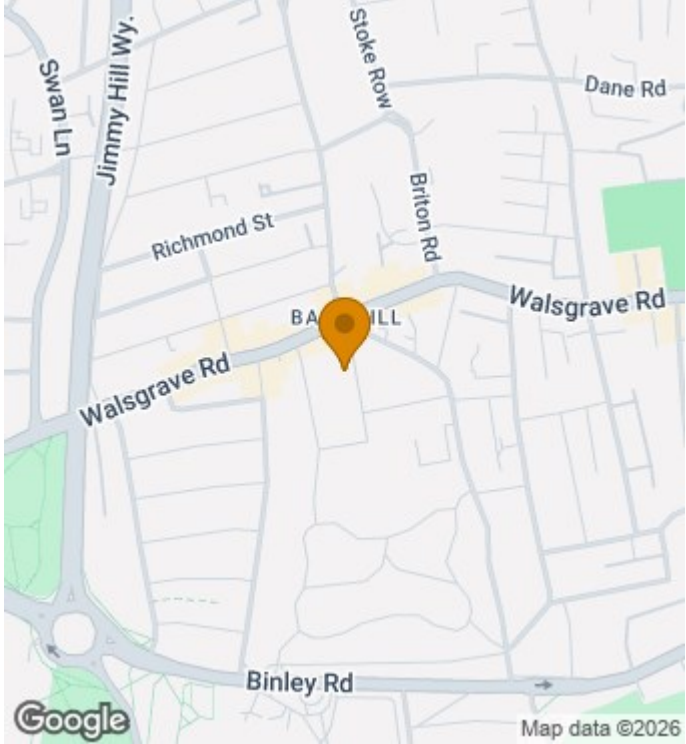




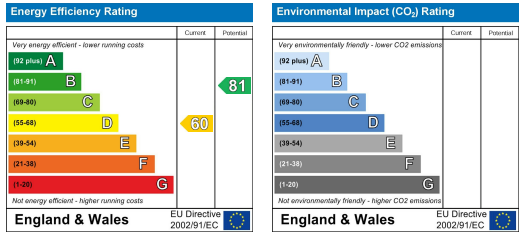
Floor Plan
