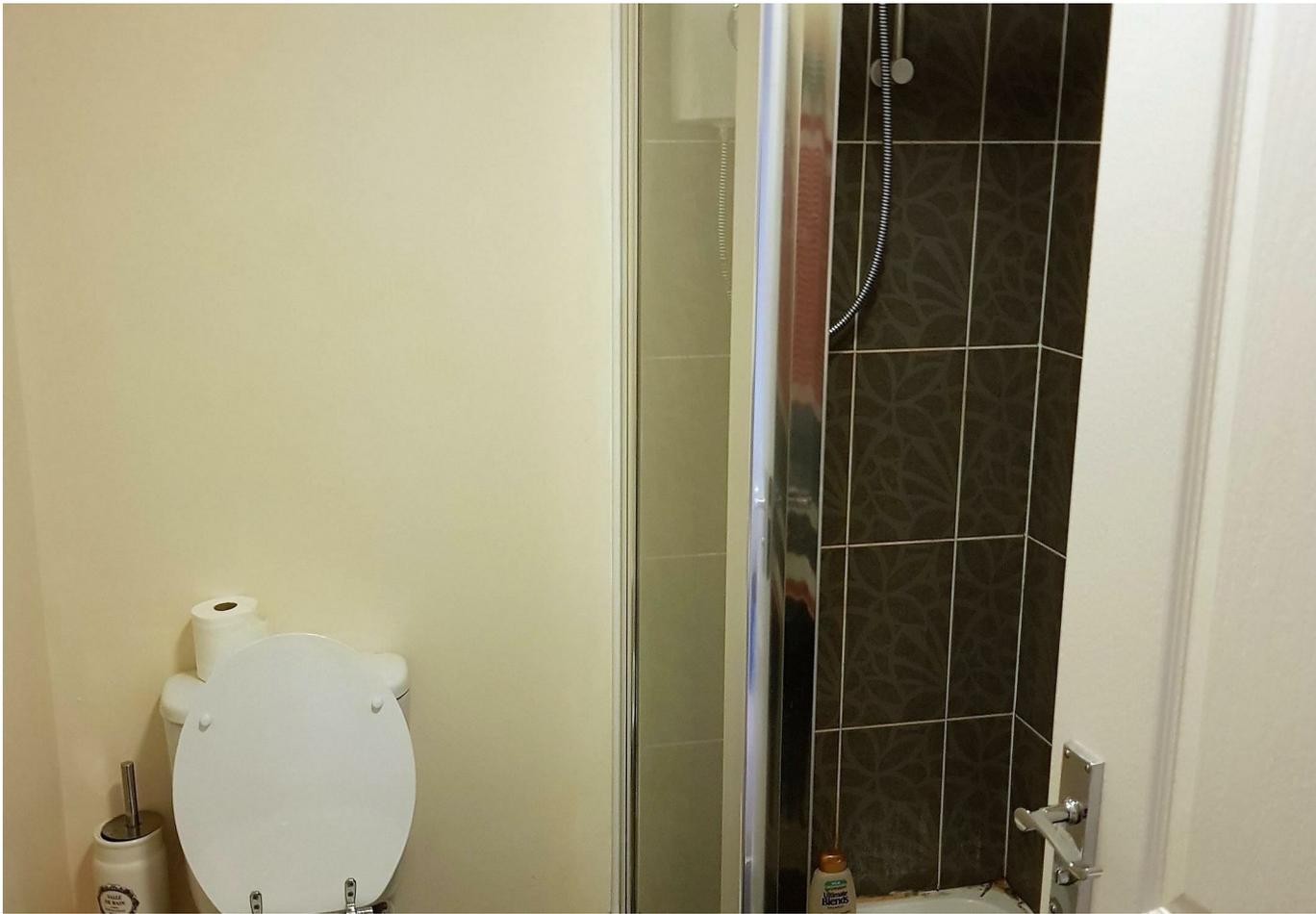

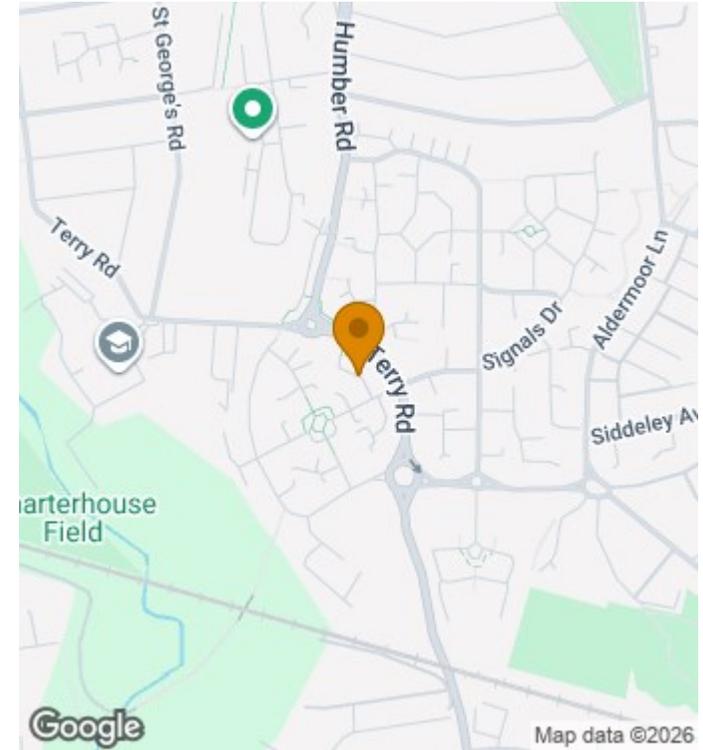


Dimensions

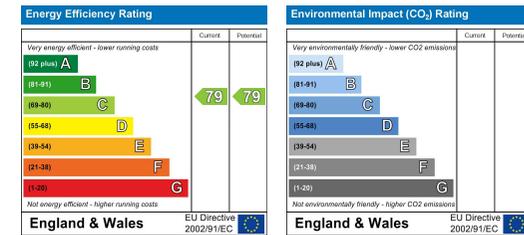
