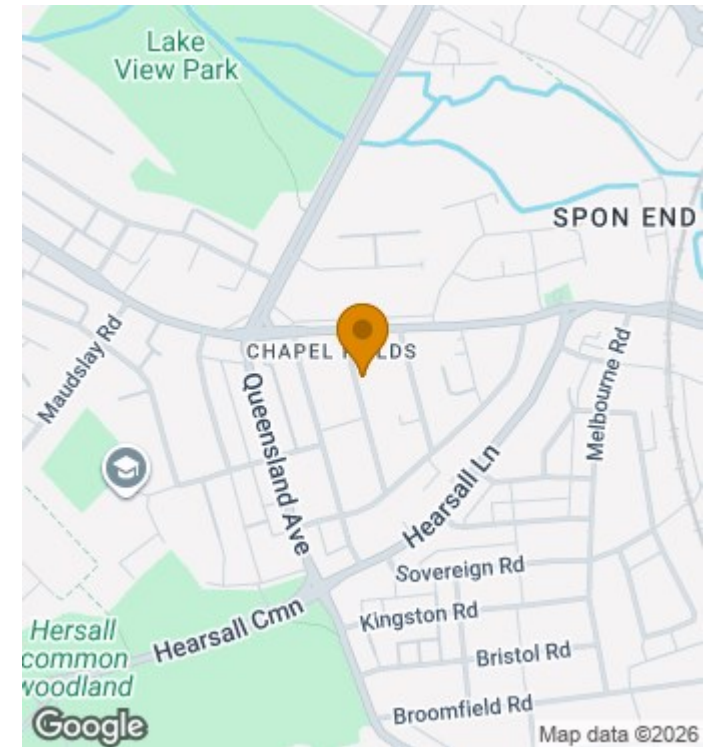




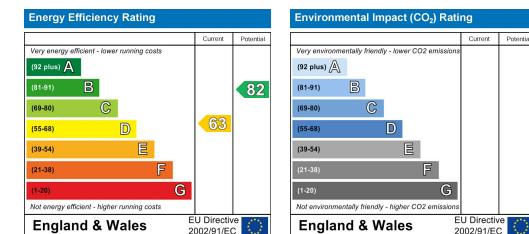




## Location Map
