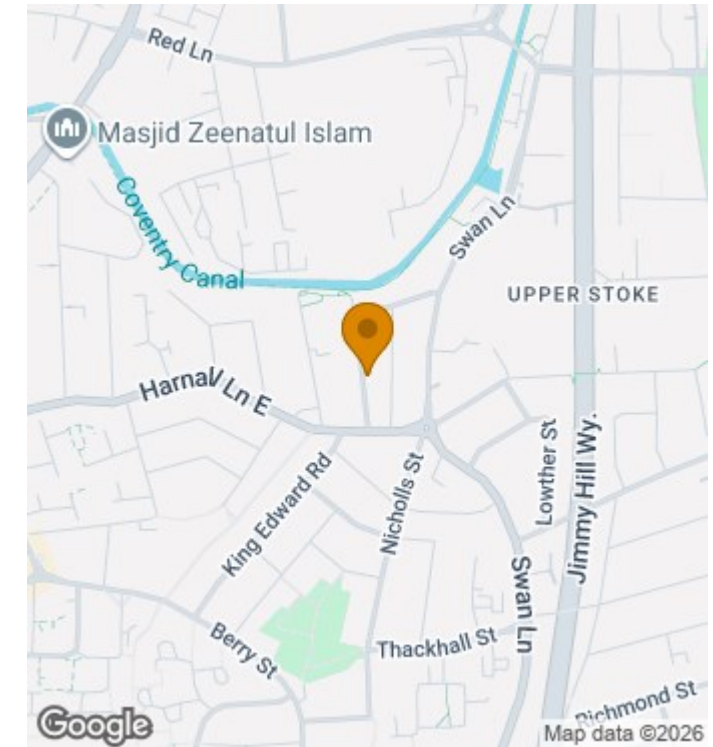




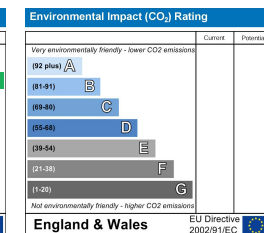
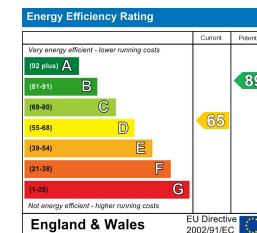




## Location Map
