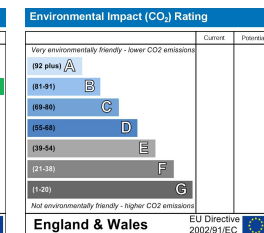
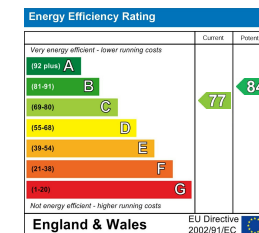




Location Map
