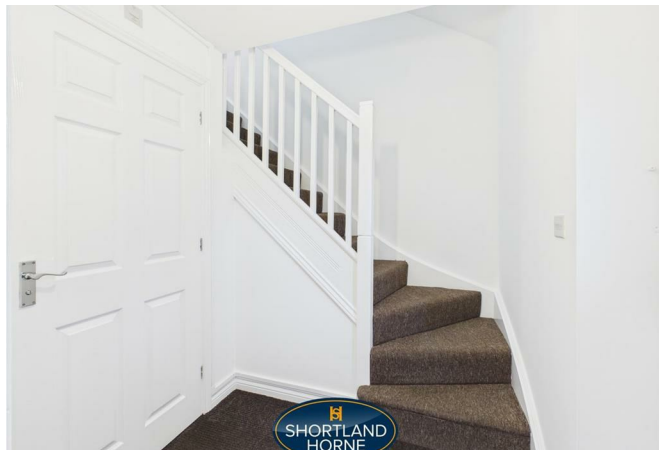

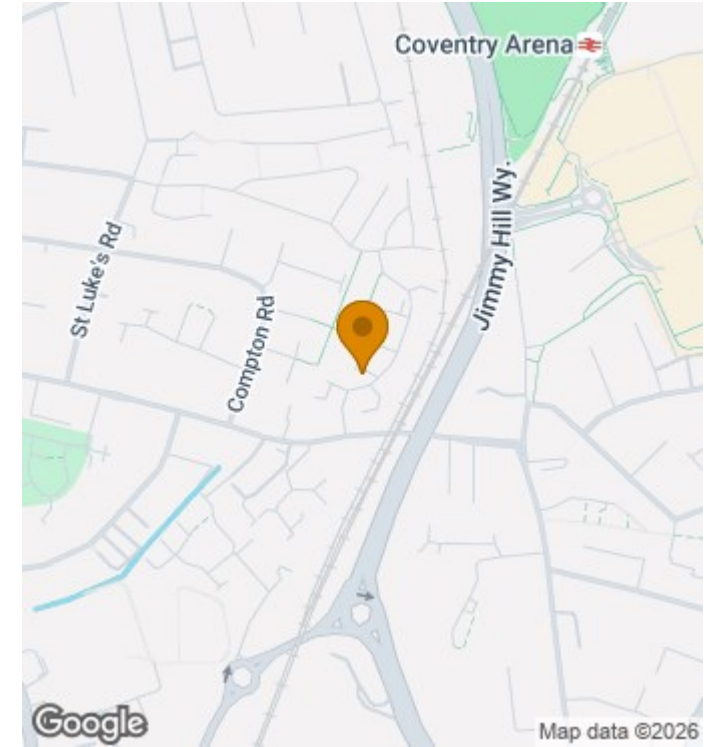

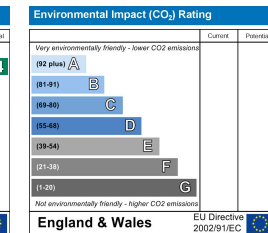
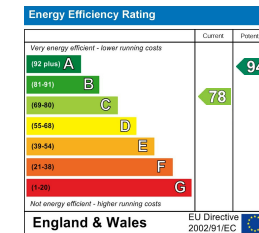
Floor Plan
