## Dining Room

3.5m x 3.5m (11'5" x 11'5")

Door and window to front. Feature fireplace with gas fore, coving and ceiling rose. Laminate flooring.

## Lounge

Window to rear. Feature fireplace and laminate flooring. Stair's to first floor and door to cellar. (Cellar not to be used for storage)
