A lovely two bedroomed semi detached bungalow with front and rear gardens, driveway and garage situated within the village of Morton On Swale. The property benefits from gas fired central heating and Upvc double glazing. 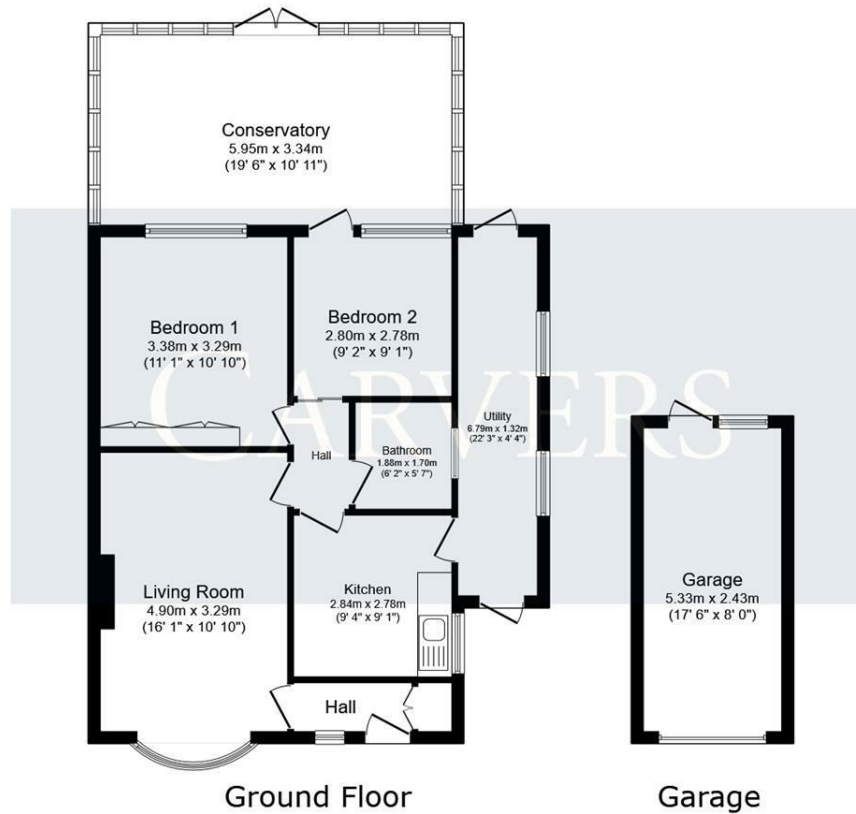
