Bolton House is a beautiful three double bedroomed detached home built to a high specification providing excellent open plan modern living accommodation with under floor heating to the ground floor and double glazing. The luxury accommodation includes a reception hall, cloak room/wc, study/office, spacious living room and a stunning open plan kitchen/dining/living room with log burning stove and bi folding doors to the rear. The kitchen area has integrated appliances including oven, hob, dishwasher, fridge freezer and quartz work tops. There is also a useful utility room with door to the side. The master bedroom has a walk-in wardrobe and a lovely en suite shower room/wc. There are two further double bedrooms and a family bathroom. Externally there is a front garden, driveway providing off street parking and access to the garage with remote door and pedestrian door to the rear garden. The rear garden is a good size with stone flagged patio and lawn with lovely far reaching views and adjoining farm land. The village is well positioned for access to Northallerton, Thirsk, A1M and A19.

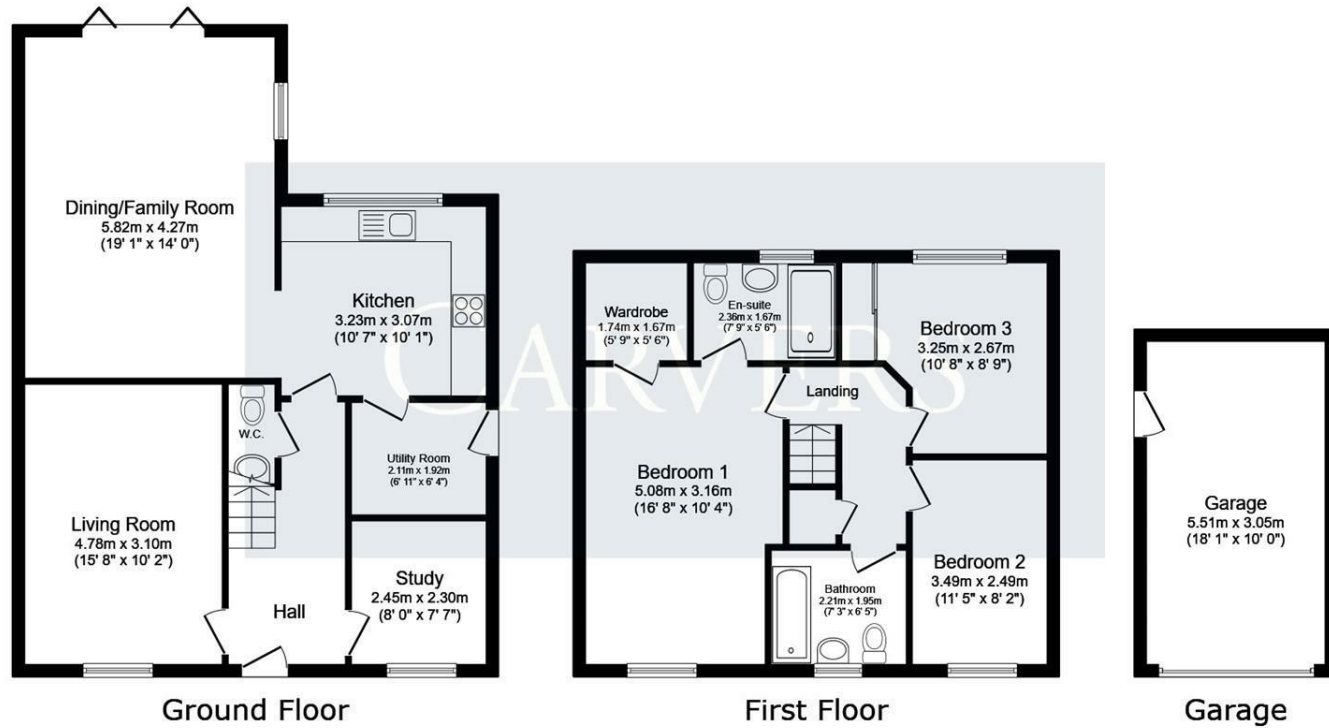
