Where to begin? This incredible Grade II listed period home in the village of Melsonby must be seen to be appreciated. Situated imposingly on a generous, elevated plot facing local green space the property is ideally located in the very centre of the village. Internal accommodation consists of an entrance hallway accessed by a wonderfully quaint period front door, living room with impressive fireplace and exposed stonework, dining room, modern kitchen diner, conservatory, utility room and home office. A ground floor WC and shower room complete the ground floor. The first floor holds a split level landing area leading to five good sized bedrooms (four of which are doubles) and a house bathroom. Externally the property holds a mature front garden with pretty walling, off street parking and carport with integrated electric charger. The rear garden holds a useful mix of lawned and patio areas with planters and storage sheds with more than enough space to enjoy those summer evenings. Roof mounted solar panels providing hot water and electricity, oil central heating and double glazing is present throughout. EPC rating D, North Yorkshire Council tax band F.

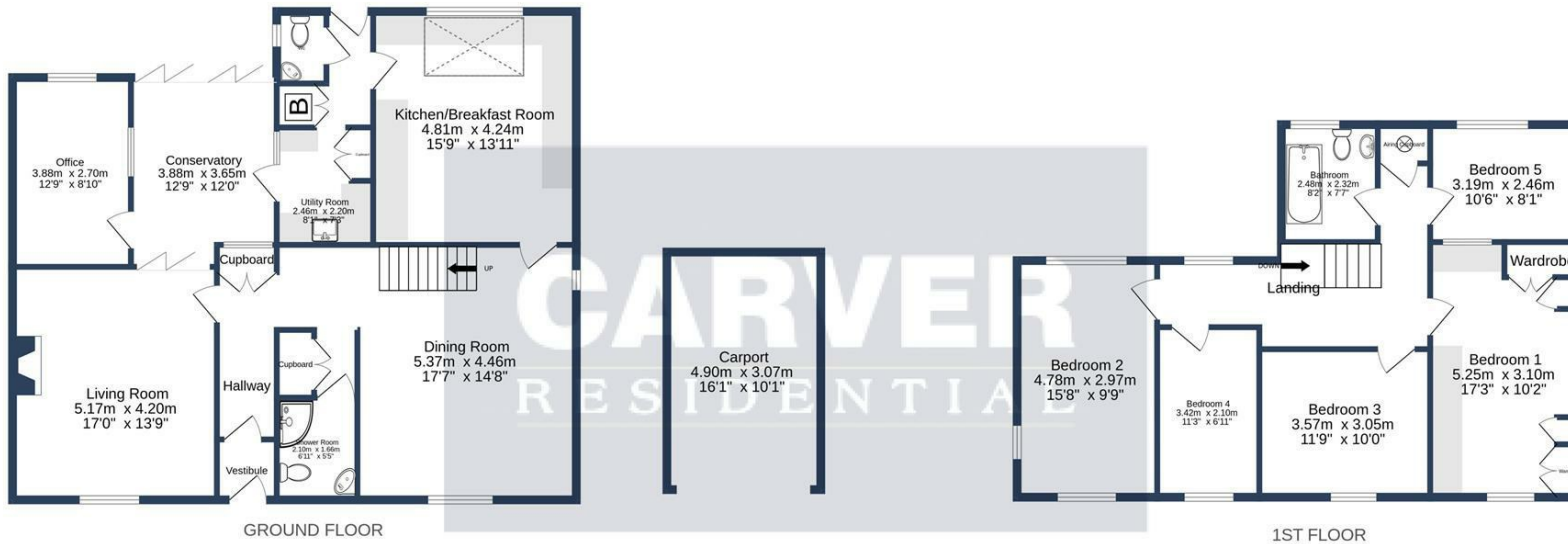
