Located on Marygate in the central, older part of the village this property has a huge number of wonderful features ready to explore. Internal accommodation consists of an entrance hallway, living room with traditional open fire, second reception room, central hallway with access to a ground floor WC and utility room, dining room with doors to rear patio and finally a well sized kitchen breakfast room. The first floor holds three good sized bedrooms and a family bathroom with storage cupboards in bedrooms one and three. Externally the property offers a walled front courtyard garden whilst the rear garden has a patio area with an expansive lawn leading to a detached home office/snug building with its own raised decking, sliding doors, power and lighting, ideal for a home office or business. 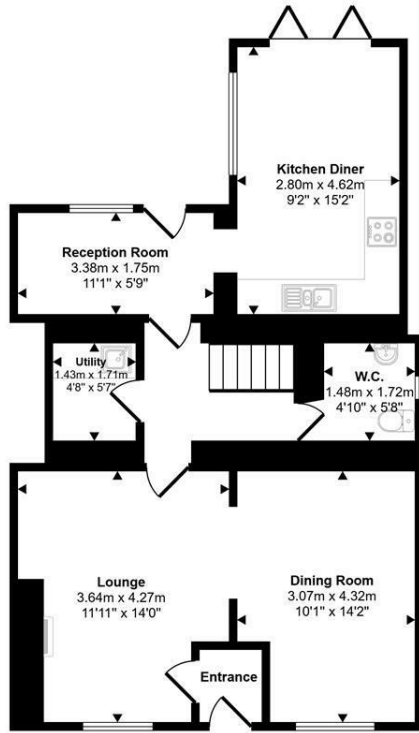

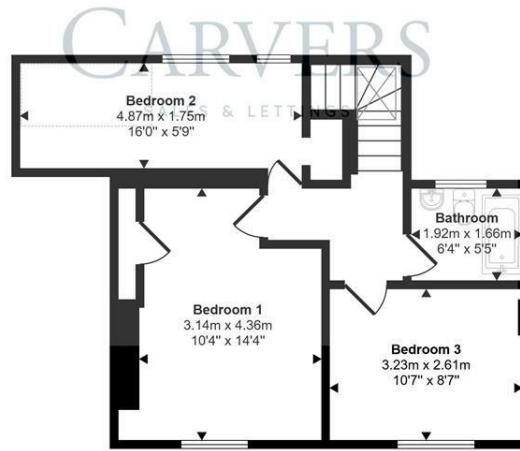

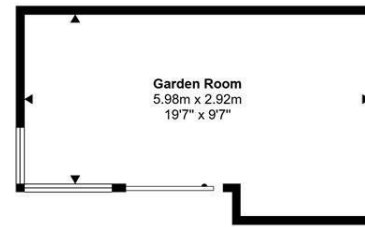


Ground Floor
