Situated within a sought-after and convenient West End location, this substantial period townhouse at 5 Polam Road offers generous and versatile accommodation set over multiple floors, making it an ideal purchase for growing families.

The property retains a wealth of original character, with attractive features including fireplaces and elegant moulded cornice work, adding charm and a sense of heritage throughout. While the home would benefit from some modernisation, it presents an excellent opportunity for a buyer to update and personalise to their own taste.

The accommodation is well laid out, with three bedrooms and a refitted family bathroom located on the first floor. The second floor provides a further four bedrooms, offering superb flexibility for larger families, guest space or home working.

To the ground floor, the property offers spacious living areas with a large lounge which has a large bay window, separate dining room with UPVC double glazed French Doors leading to the garden, kitchen/breakfast room, garden room, utility room and a separate w.c. The ground floor is complemented by a large basement which provides excellent storage or potential for further development, subject to the necessary consents.

Externally, the property stands on a good-sized plot with gardens to both the front and rear, along with the added benefit of a double garage.
