Occupying a convenient position close to a wide range of local amenities, this attractive bay-fronted period terrace is far more spacious than its appearance from the roadside might suggest. Offering well-proportioned accommodation together with a particularly impressive rear garden, it is a home that will appeal to first-time buyers, growing families and those simply looking for generous living space.

The welcoming entrance hallway leads to a lovely front lounge where the bay window fills the room with natural light, while the fireplace provides an attractive focal point. To the rear is a superb 19ft kitchen and dining room, creating an excellent everyday living space with ample room for both cooking and entertaining. Double doors open into the conservatory, providing a pleasant place to relax whilst enjoying views over the garden.

One of the property's standout features is undoubtedly the rear garden. Larger than many found with similar homes, it has been thoughtfully landscaped with an extensive lawn, mature planting and a delightful patio area, making it ideal for both children and outdoor entertaining.

The first floor offers three well-proportioned bedrooms, including a particularly attractive principal bedroom with a bay window and original fireplace, together with a family bathroom/WC.

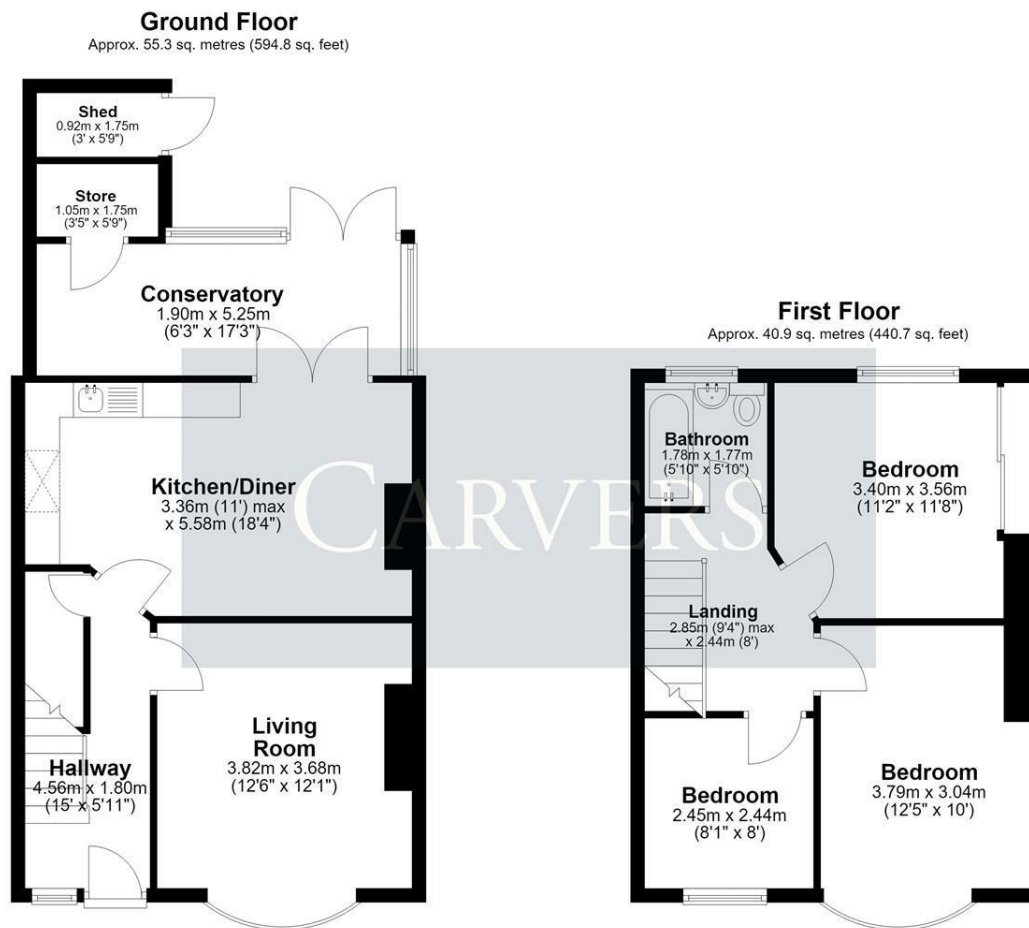
