A particular highlight of the property is the impressive 21ft kitchen/breakfast room, fitted with an excellent range of units and integrated appliances, creating an ideal space for both everyday living and entertaining. Externally, the bungalow continues to impress. 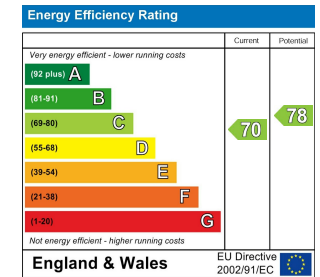
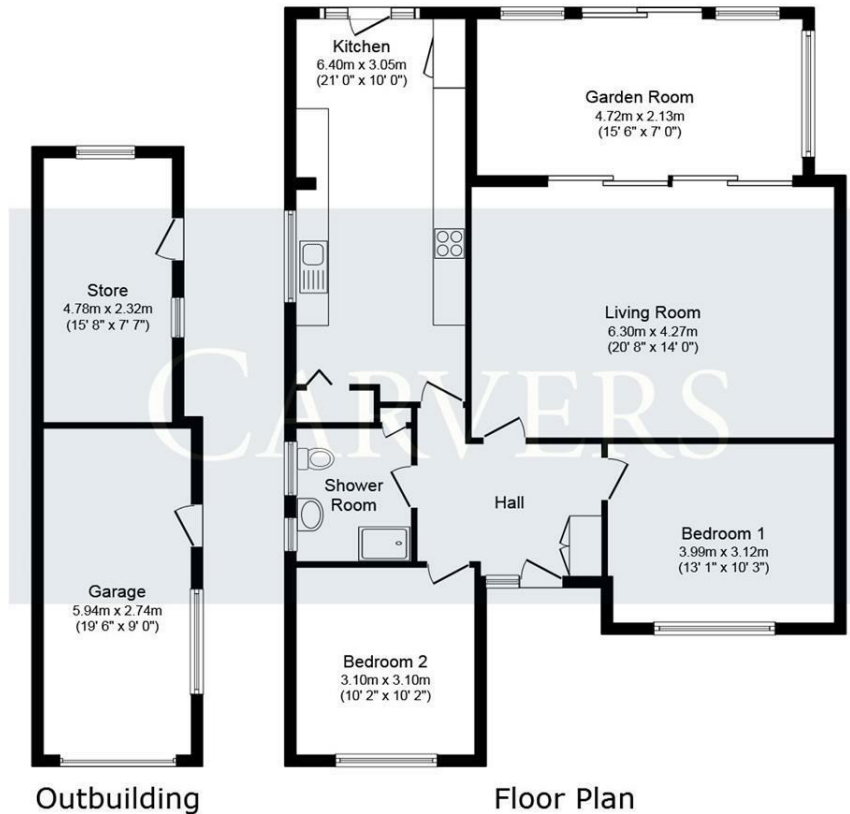
