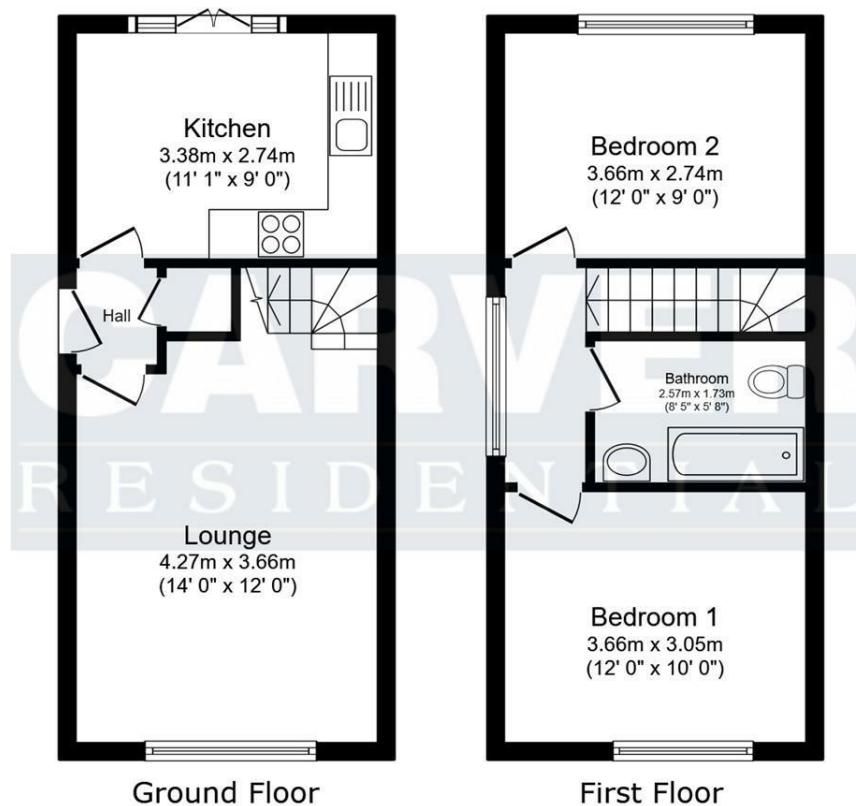
#### Buyers Identification Checks
