This absolutely vast property boasts an impressive layout, with six generous bedrooms arranged over the upper two floors, three of which benefit from their own en-suite facilities, providing comfort and privacy in abundance.

To the ground floor, the home offers remarkable living space with four well-proportioned reception rooms, creating superb flexibility for both formal entertaining and everyday family life.

A particularly noteworthy feature is the self-contained one-bedroom flat located on the first floor, complete with its own private entrance. This offers excellent potential for use as an annex for a dependent relative, guest accommodation, or indeed as a holiday let/Airbnb, providing an additional income stream if desired.

Externally, the property is further enhanced by the presence of a double garage, adding valuable parking and storage as well a good size yard and a lawned garden.
