House - Semi-Detached



A very well presented and much improved modern semi-detached house, offering well-proportioned accommodation which has been enhanced and improved by the current owner. The property provides a comfortable and practical home with attractive living space and gardens to both the front and rear.

The accommodation begins with an entrance hallway and useful cloakroom/W.C., leading through to a good-sized lounge. The lounge has UPVC double-glazed French doors opening directly onto the rear garden, creating a pleasant connection between the living space and the outside.

There is also a well-appointed kitchen/dining room, fitted with an attractive range of floor and wall units incorporating integrated appliances, providing a good-sized space for both everyday dining and entertaining.

To the first floor are three bedrooms, with the master bedroom being particularly well proportioned, together with a family bathroom/W.C.

Outside, the property has gardens to both the front and rear, with the rear providing a pleasant space for sitting out and enjoying the garden with a wood decked patio area. There is also the benefit of a dedicated car parking space.

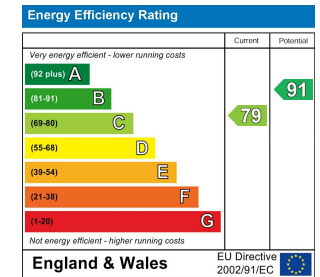
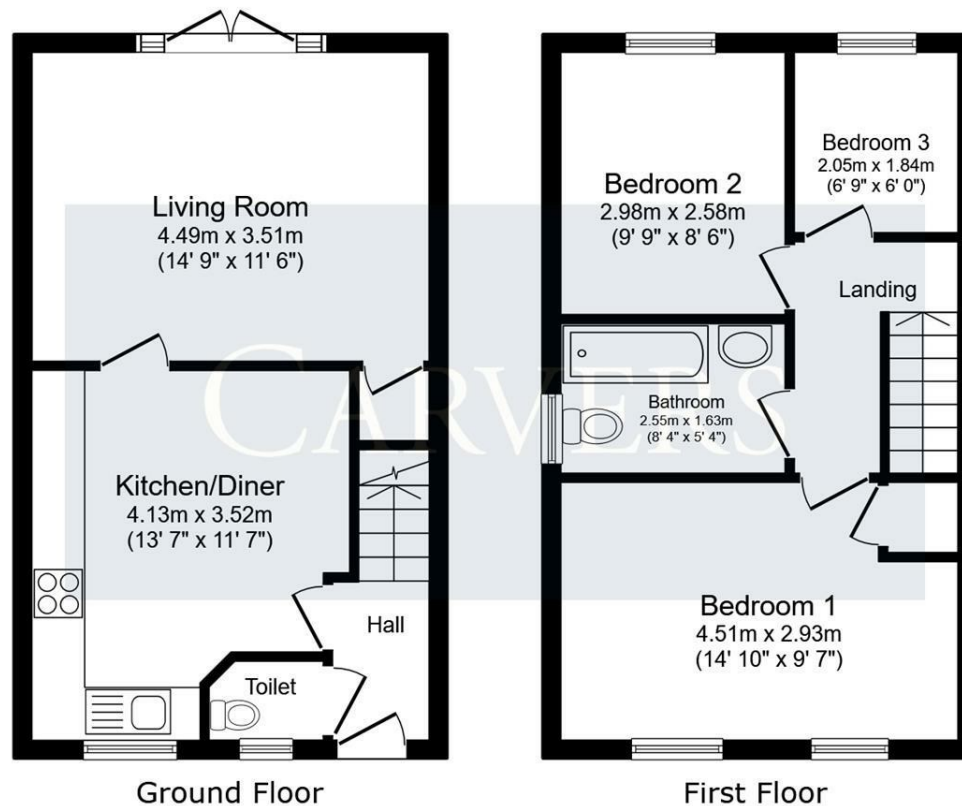
Buyers Identification Checks
