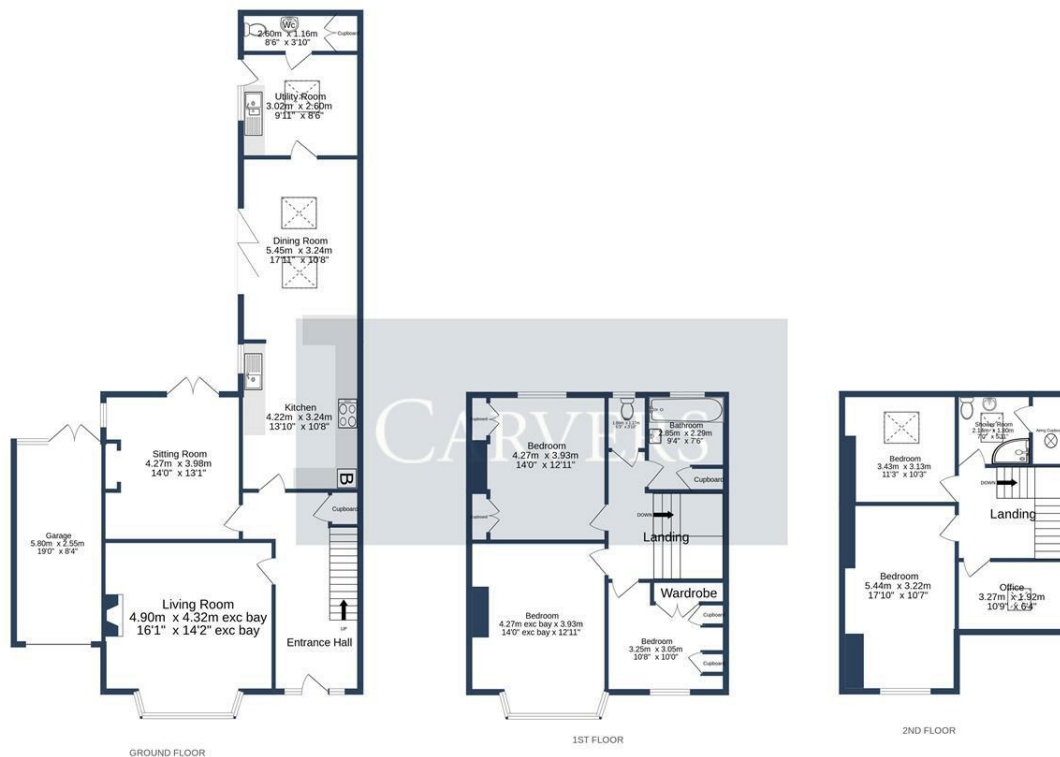
Buyers Identification Checks
