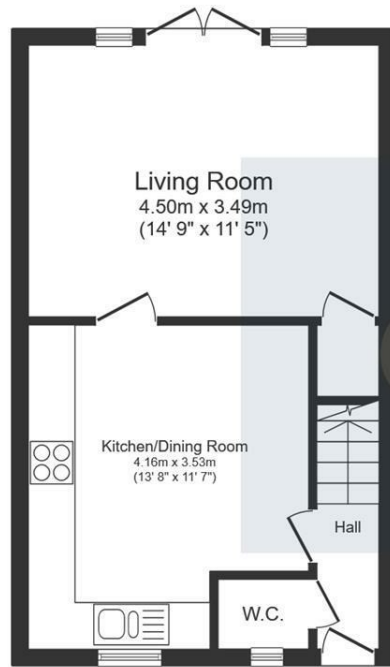
**Buyers Identification Checks**

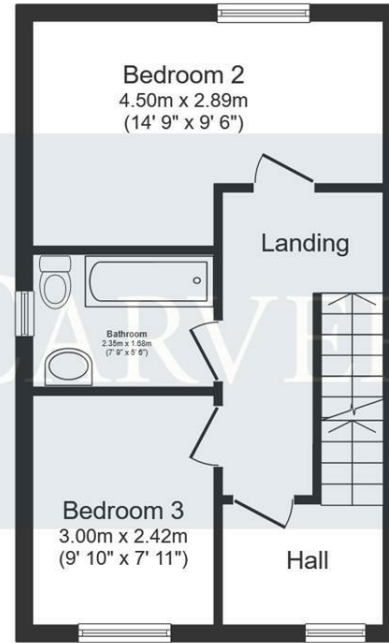

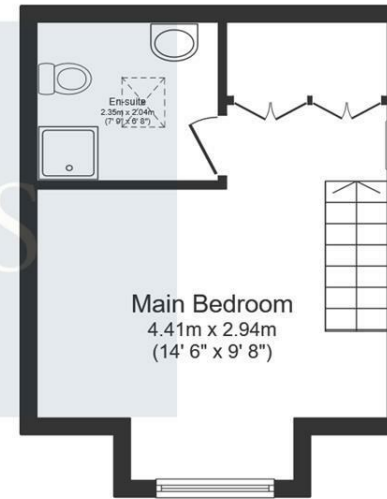




Ground Floor
