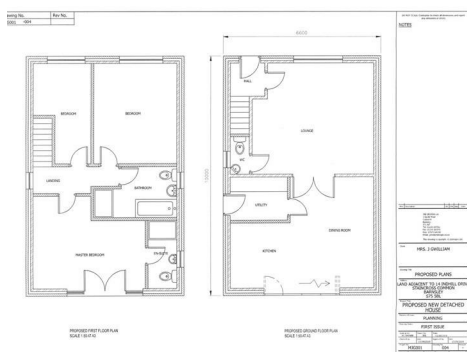

- 4 Construction or remediation work comprising the use of plant, machinery or equipment, or disturbance of materials shall only take place between 08.00hrs and 18.00hrs on 4 days a week.

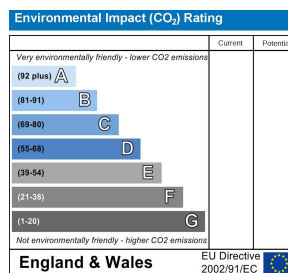
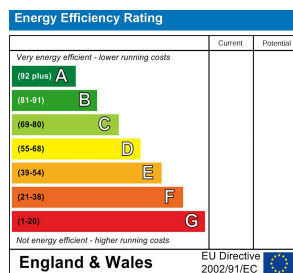
