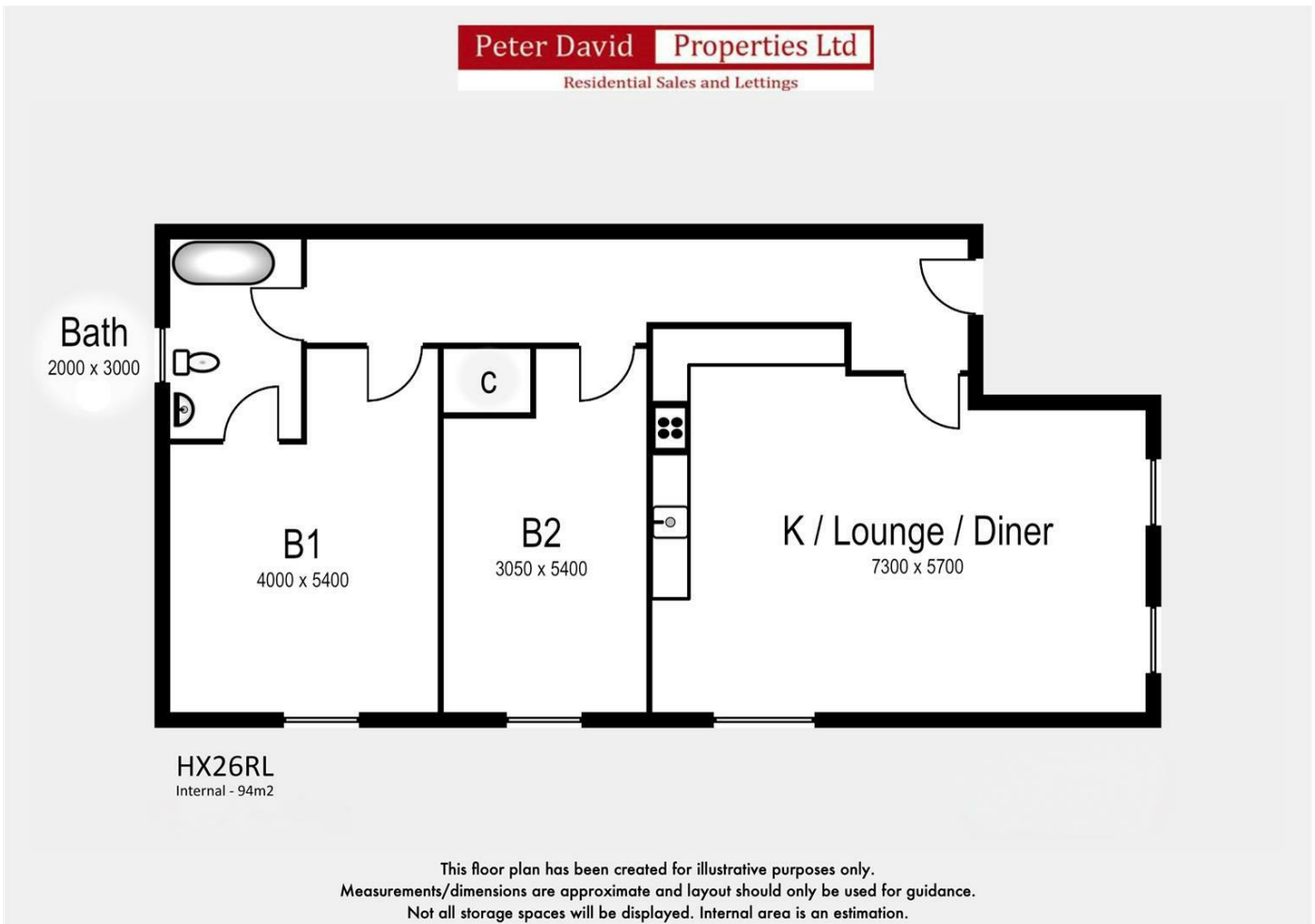
Hybrid Map



Terrain Map



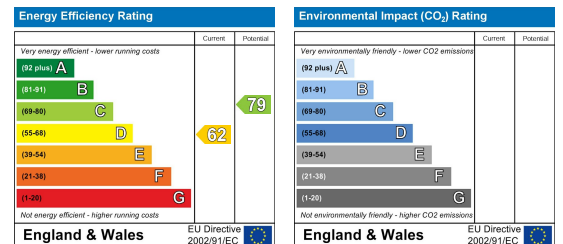
Floor Plan
