At the heart of the property is a spacious granite farmhouse, renovated in 2013, offering four bedrooms, three bathrooms and three reception rooms. The home retains character and original features throughout, including original granite fireplaces fitted with multi fuel stoves, creating a warm and timeless feel. Adjoining the main house are two substantial barns which offer immediate and exciting potential. The attached western barn, extending to approximately 2,000 sq ft, benefits from planning permission to convert into further accommodation or an additional dwelling. The attached eastern barn currently provides a large utility area, office space, a consulting room and extensive storage at ground floor level, with approved plans for a first floor apartment above, offering yet more flexibility for family, guests or ancillary use. In addition, there is a detached and already renovated one bedroom | two bathroom character bake house, complete with an original fireplace and multi fuel stove, ideal for guest accommodation or independent living. For equestrian use, the property is exceptionally well appointed with two detached blocks of stables accommodating at least six horses, along with approximately 15 verges | 6.5 acres of fenced land and an all weather ménage. There are also options to rent additional land if required. Outside, the setting is equally impressive with fantastic rural and sea views, ample yard space and plentiful parking.

The location is peaceful yet practical, with a great bus route and easy access to amenities and major schools, making day to day living and the school run straightforward.

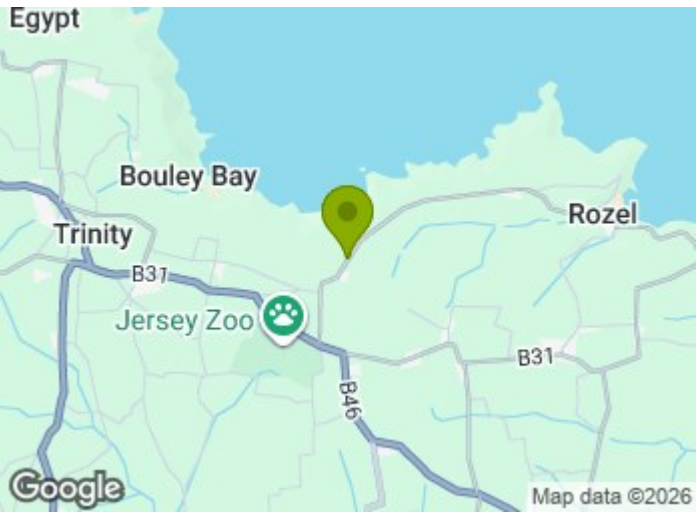
