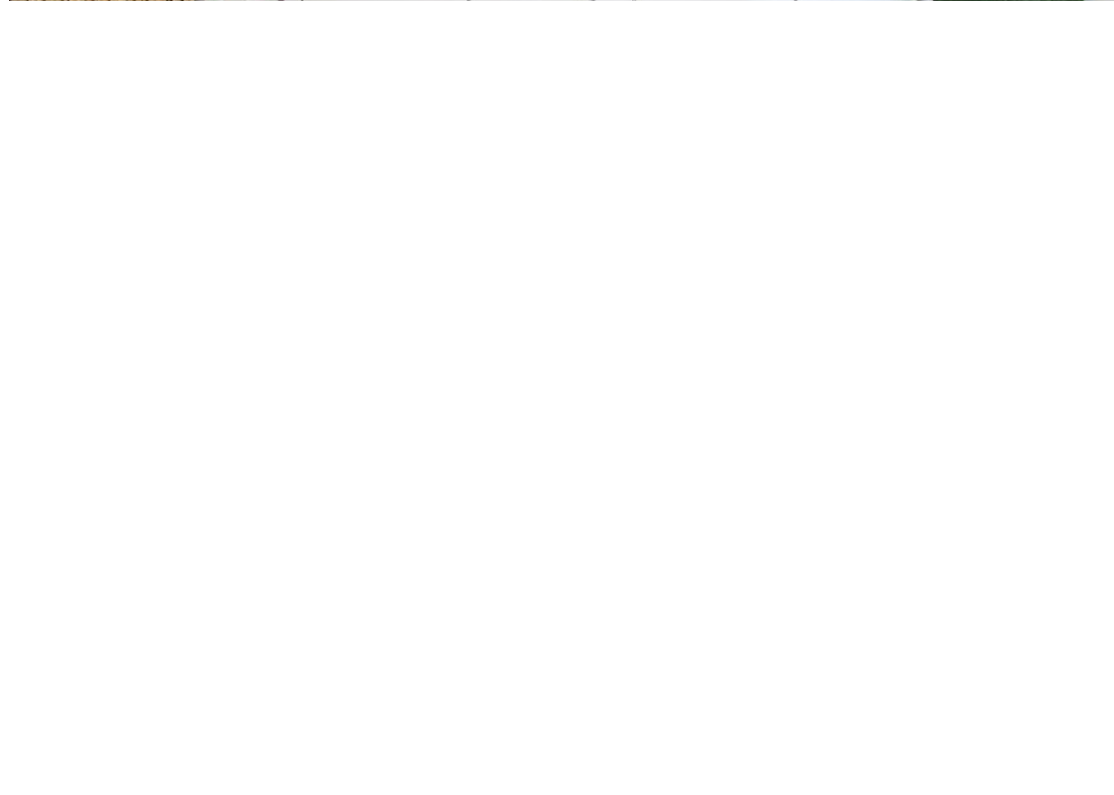

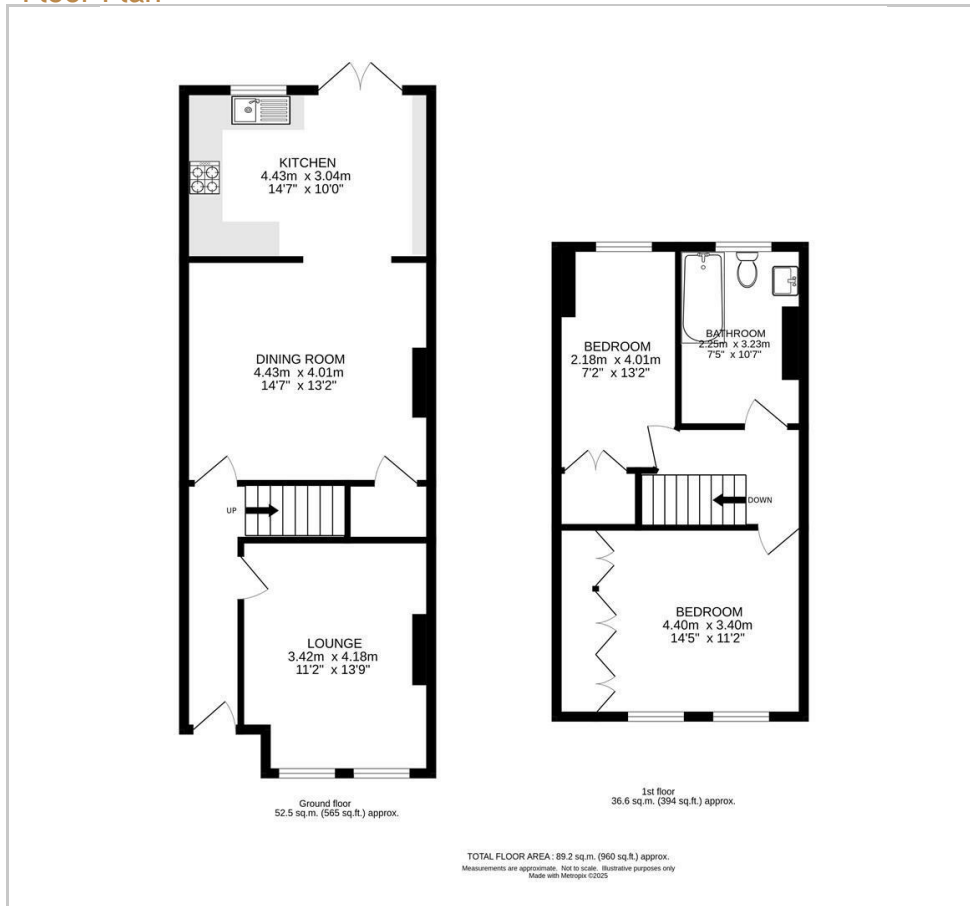






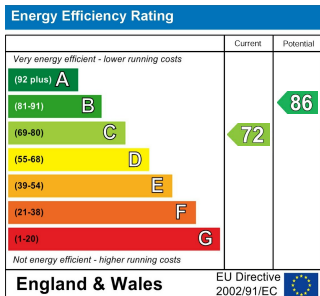


## Floor Plan
