Double glazed window to the rear, electric heater.

Modern well appointed bathroom comprising of a white suite that includes bath with shower fitted over, wash basin and toilet. Double glazed window to the side, heated towel rail / radiator.

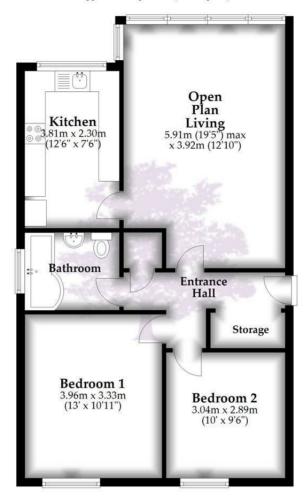






Floor Plan
