




The Smithy Skipton Bridge, Thirsk, YO7 4SB

Main Residence

This beautifully presented family home offers a well-balanced layout across two floors. The The property is Freehold ground floor features a modern kitchen with excellent storage, ample countertop space. Council: North Yorkshire and integrated appliances. Adjacent to the kitchen is a dining room, complete with an open Tax Band: D fire and a large front-facing window. Flowing seamlessly from the dining room is the living EPC: D room, which transitions into a cosy snug area. The ground floor is 5114-1171 completed by a staircase leading to the first-floor accommodation.

On the first floor, a spacious split-level landing provides access to the bedrooms and a generous bathroom. The property offers two large double bedrooms and a smaller double room. The modernised bathroom features a panelled bath with a shower, a WC, and a wash hand basin set within a vanity unit with storage beneath. Additionally, there is a highly practical double-height linen store, enhancing functionality.

Externally, the private gardens are beautifully maintained and well-stocked, featuring multiple seating areas surrounding a central lawn. Additionally, the property includes a large greenhouse or plant nursery, perfect for gardening enthusiasts.

Previous Dwelling

Entry to the unit is via a generously sized living room, leading to a well-appointed kitchen. are owned by Luke Miller & Associates. All rights are reserved. From the kitchen, a door opens to the inner hall, providing access to the bedroom, shower room, and WC. This space is perfect for intergenerational living or can be adapted for rental or AirBnB opportunities. To convert this back to a dwelling, we advise that the local council / planning be contacted.

Garage / Workshop

Accessed through double timber doors, this versatile space is perfect for use as a garage or workshop. There is power and lighting.

The Forge

While historical information is still being gathered, the original furnace remains intact, along with the cobbled and brick flooring. With vision and additional investment, this area could be transformed into a variety of functional spaces, such as an additional reception room, office, or even a 'man cave.' Directly in front of the Forge is a gravelled area and double timber access gates. The lane that these gates are accessed is a owned via the property to the rear and vehicle rights are permitted.

The Village of Skipton On Swale

Skipton-on-Swale, located in North Yorkshire, has a rich history that is reflected through its architecture and historical landmarks. Notably, the Swale Bridge, a Grade II listed structure built in 1781, is an example of the region's architectural heritage and craftsmanship. The village also boasts buildings like Skipton House, which contribute to the area's historical fabric. Located along the River Swale, the village offers idvllic countryside views and peaceful walking trails, making it a haven for nature lovers.


