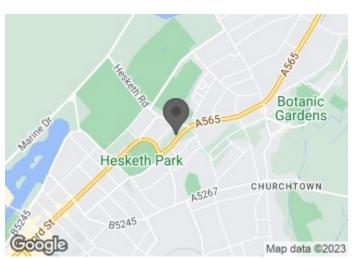

ENTRANCE HALL

Front door with spy hole leads to the large entrance hall - the 24-hour Tunstall emergency response pull cord system is situated in the hall. From the hallway there is a door to a walk-in storage cupboard/airing cupboard. Illuminated light switches, smoke detector, apartment security door entry system with intercom and emergency pull cord located in the hall. Doors lead to the bedrooms, living room, bathroom and Cloaks/WC.

LOUNGE

Juliet balcony with lovely garden views. Additional upvc window to side allowing additional light. Feature fire with fitted electric fire. TV and telephone points. Ceiling light. Fitted carpets, raised electric power sockets. Partially glazed doors lead onto a separate kitchen.

KITCHEN

uPVc window to side with garden views. Fully fitted kitchen with tiled floor. Stainless steel sink with mono block lever tap. Built-in oven, ceramic hob with extractor hood and fitted integrated fridge, freezer and under pelmet lighting.

BEDROOM ONE

UPVC window to rear offering views over landscaped gardens. Ceiling lights, walk-in wardrobe. TV and phone point.

CLOAKS WC

Fully tiled and fitted with suite comprising of WC, vanity unit with sink and mirror above.

BEDROOM TWO

Spacious second bedroom with window allowing garden views. Ceiling lights. TV and phone point.

SHOWER ROOM
