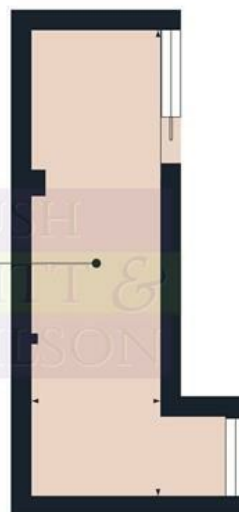

This level also benefits from a generous living room featuring a large bay window and French doors opening onto the rear garden. Without doubt, the garden is one of the property's standout features. Extensively landscaped to create a stunning, low-maintenance outdoor environment, it offers multiple levels designed for both entertaining and family enjoyment. Raised decking with glass balustrades takes full advantage of the far-reaching views, while steps lead down to a bespoke home bar, lawned areas, climbing wall, trampoline space and further private decked seating areas. LED lighting integrated into the steps provides a striking ambience throughout the evening. The hall floor offers a spacious kitchen/dining room, perfectly positioned to enjoy the magnificent outlook, together with the fourth bedroom. To the first floor are three further well-proportioned double bedrooms and a family bathroom serving the accommodation. To the front, the property benefits from valuable off-road parking for at least two vehicles. Ideally situated within the popular Clive Vale area, the property is within easy reach of highly regarded local schools, including Sacred Heart, whilst Hastings Historic Old Town, seafront, cafes and amenities are all just a short distance away. 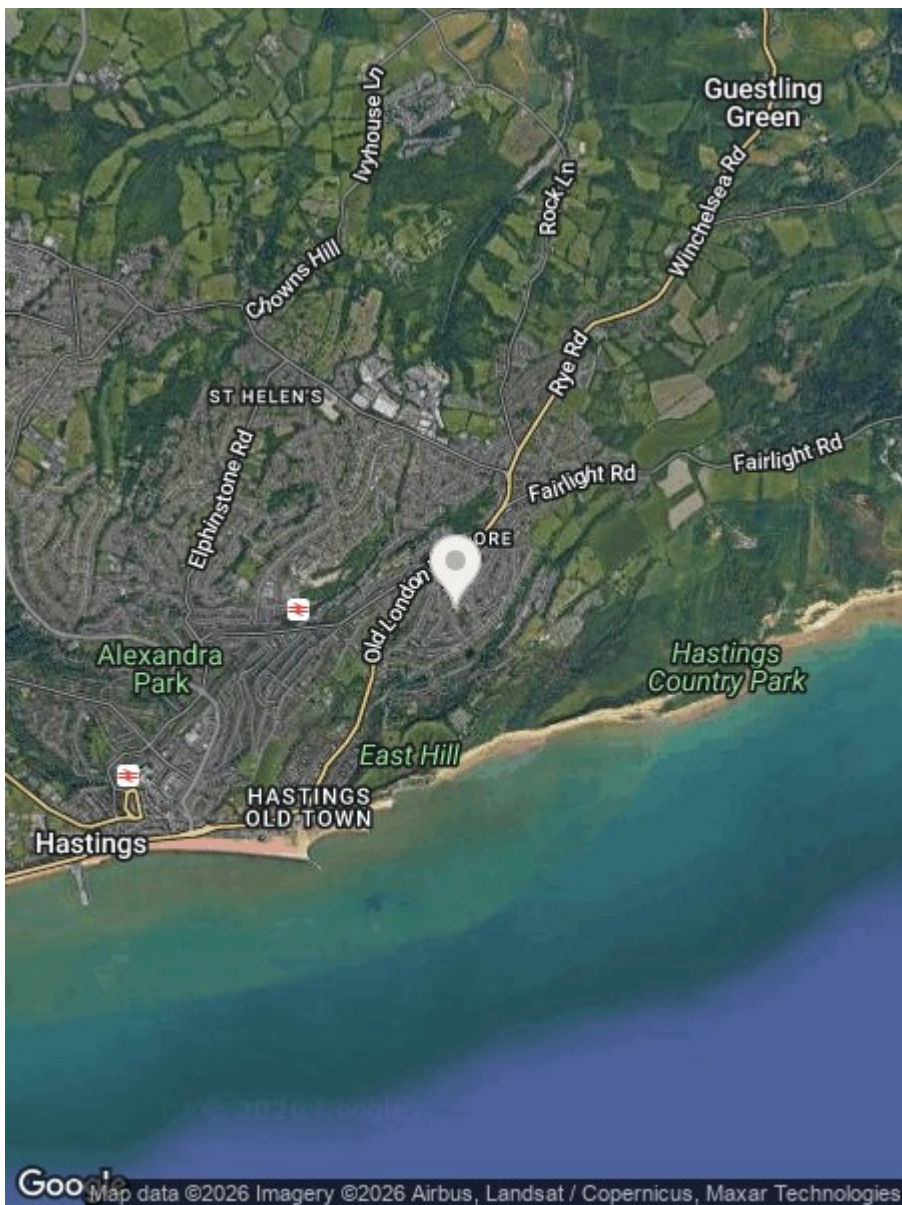
