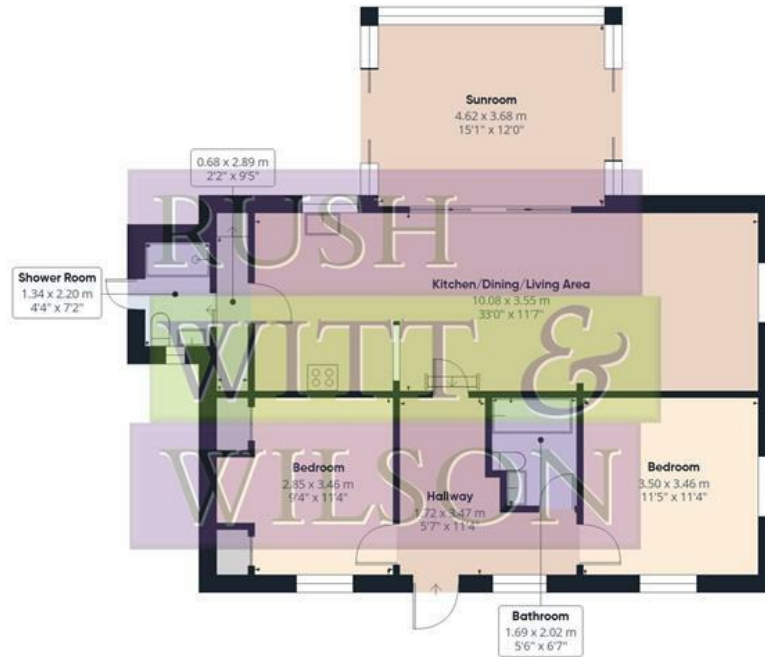

Approximate total area⁽¹⁾

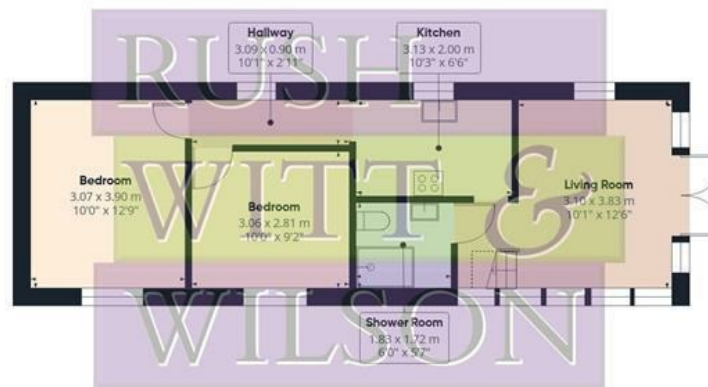

Floor 0 Building 2

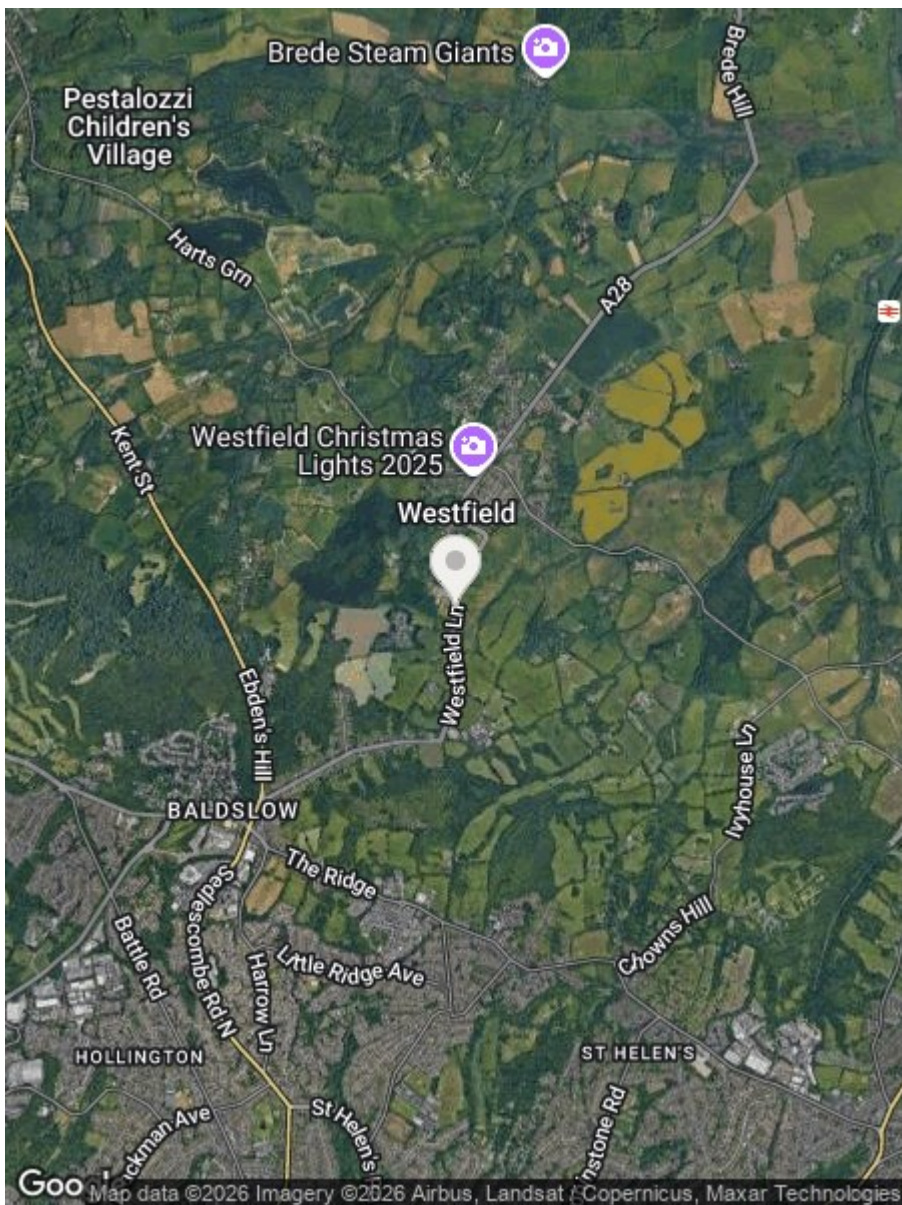
