3 Clifton Street is a charming period mid terrace home located on this popular road in the heart of Alderley Edge Village.

The property has been extended and offers spacious and versatile accommodation throughout. On the ground floor is the entrance hall, living room with feature fireplace (with log burning stove) open to the dining room with exposed brick fireplace. The breakfast kitchen has contemporary units, contrasting worksurfaces and integrated appliances. The kitchen has double French doors leading to the garden.

To the first floor are two well-proportioned double bedrooms and the family bathroom. On the second floor is the spacious principal bedroom, having exposed brickwork with an en-suite shower room.

Externally is a well-established front garden, whilst to the rear is an enclosed paved courtyard garden with boundary walls and shrubs.





Clifton Street occupies a charming location in the heart of the village. Alderley Edge village offers a good range of shopping including the Waitrose supermarket, stylish boutiques and fine restaurants.


