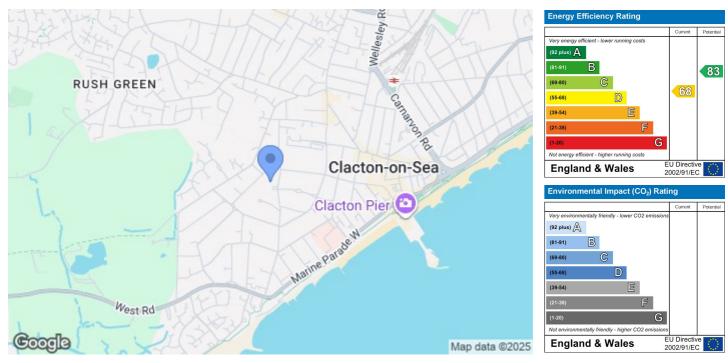

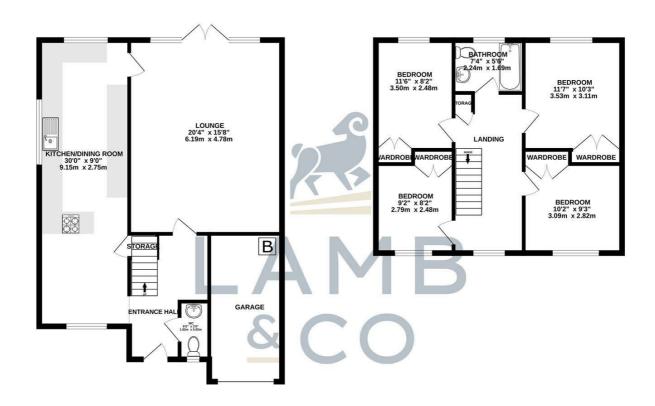




Map EPC Graphs
