Map

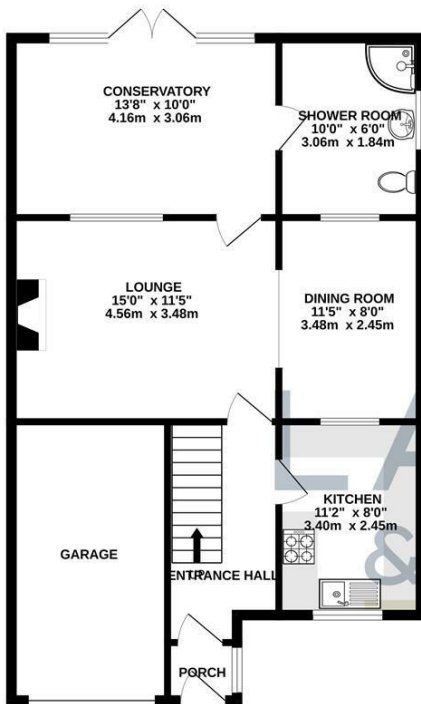
