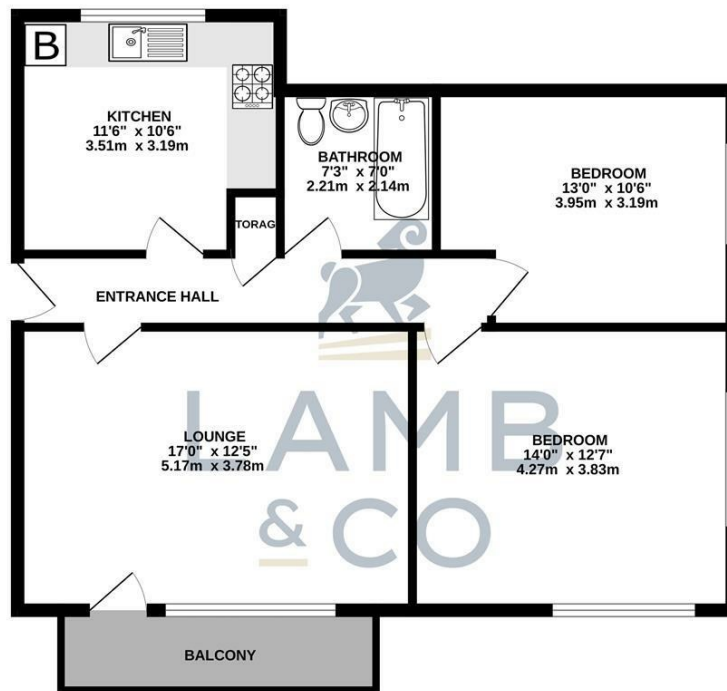
Map
