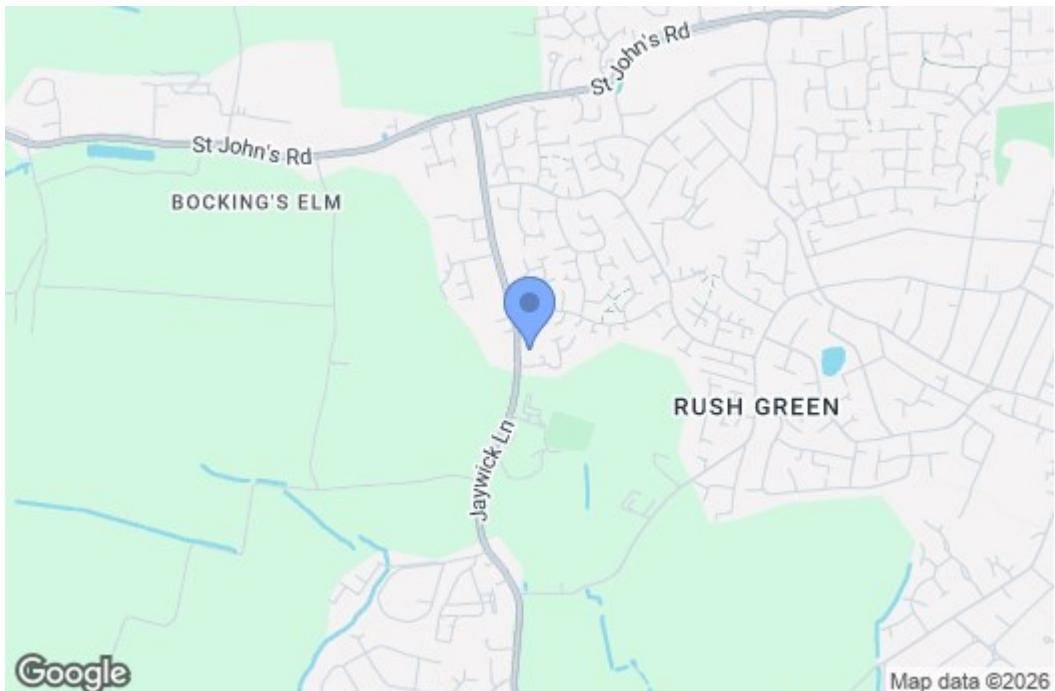

Map

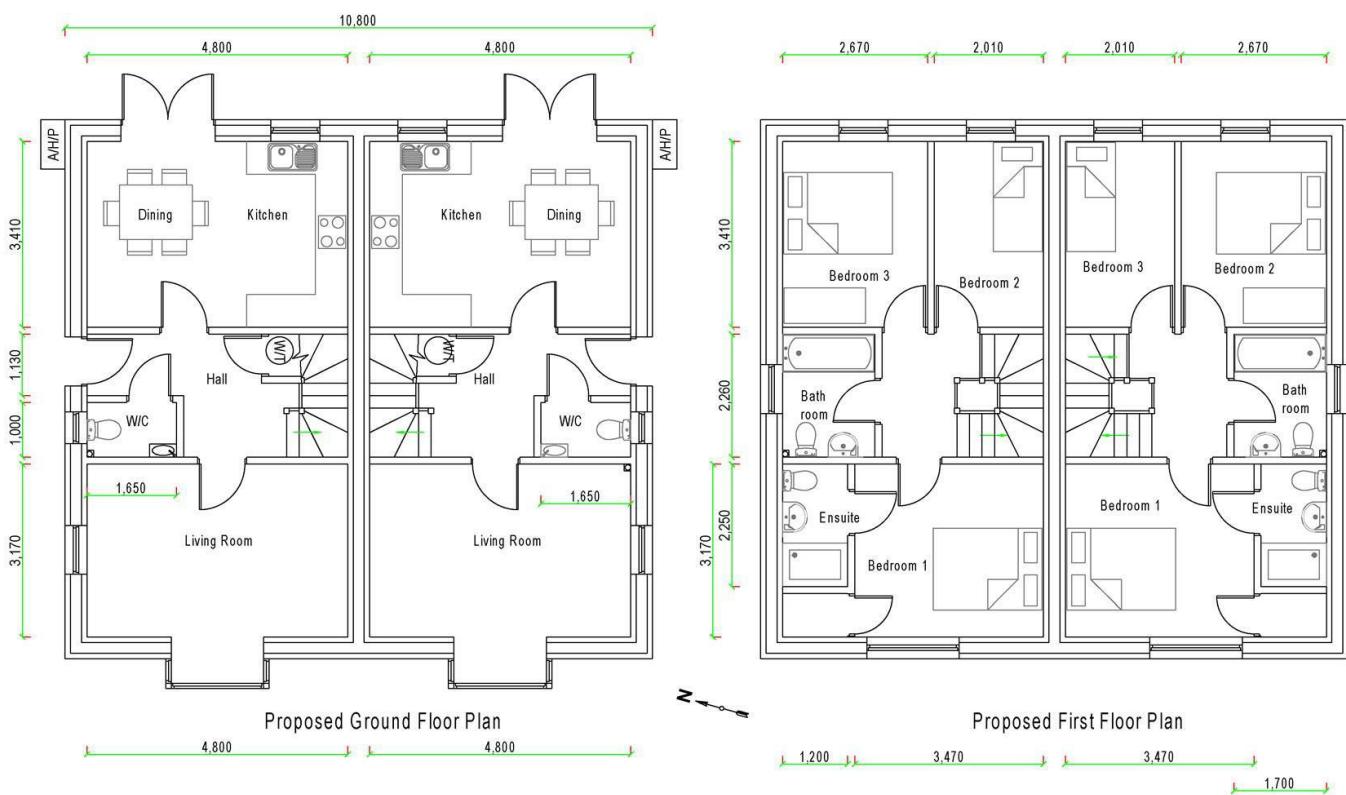
