The Property

Occupying the top floor of this attractive and imposing Grade II* listed Georgian terrace, a stones throw from the vast range of attractions and amenities found in Clifton Village.

The property has been meticulously looked after during the current ownership and is presented superbly well throughout.

The reception room is located at the rear of the building and benefits from period feature fireplace, stunning vaulted ceilings with skylight, exposed brickwork and beams as well breath-taking panoramic views across the harbourside and countryside beyond. There is recently installed separate kitchen which boasts a range of classic shaker style units, composite granite worktops, induction hob, extractor hood, oven and an integrated dishwasher and fridge/freezer.

Both bedrooms are good sized doubles with the spacious master benefiting further again from the impressive vaulted ceilings, skylight and exposed details.

Further benefits include 2 storage cupboards in the hall as well ass access to a south facing communal residents garden located to rear of the terrace.

Location

Clifton Village is one of the most unique and sought after locations in the City. From its very early days as a Spa destination to the later Georgian and Victorian influences Clifton offers charm at every turn from the fine sweep of Royal York Crescent to the grandeur of Victoria Square. At its heart lies the picturesque "Village" offering an eclectic range of independent shops, boutiques, cafes, bars and restaurants including Cote, The Ivy and the Avon Gorge Hotel. The Downs offers four hundred acres of green public space whilst Brunel's Clifton Suspension Bridge provides a gateway to the Ashton Court Estate with its woodlands, mountain bike trails and walks whilst there is excellent access to the exciting Harbourside district, the City Centre and Temple Meads.

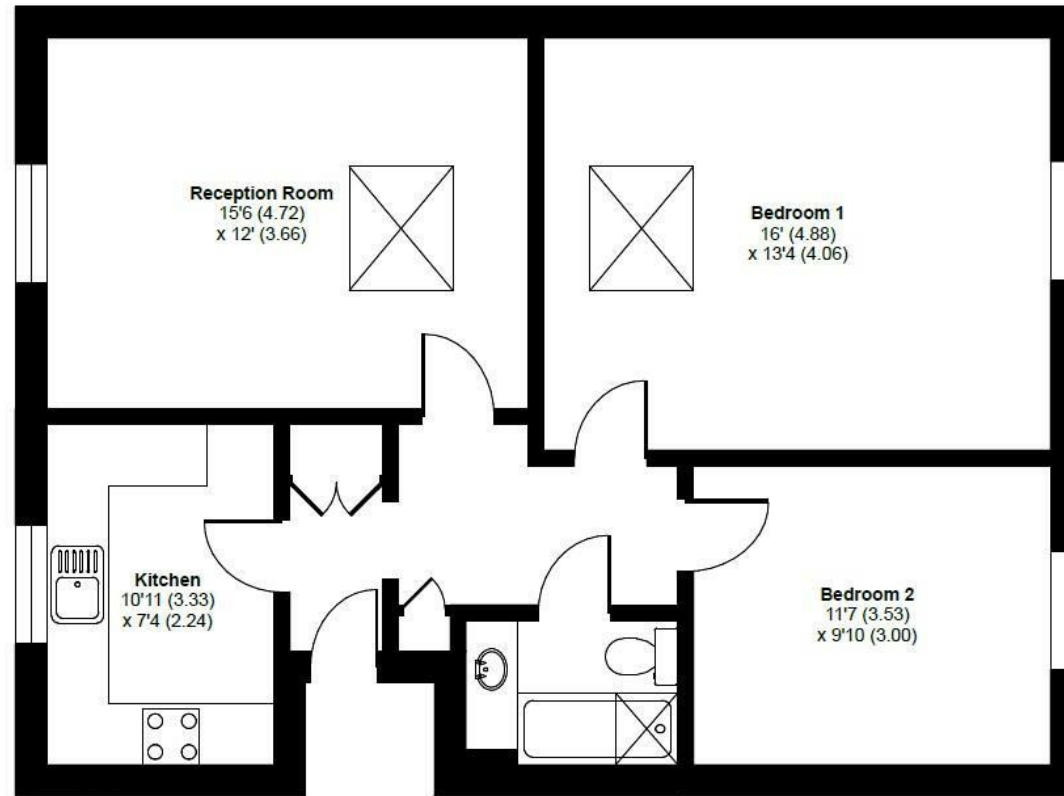
