The Property

This spacious and modern apartment is located on the top floor of this recent purpose built development, situated a few yards from the popular and attractive Portland Square and within very easy reach of the City Centre, Cabot Circus, Temple Meads train as well as Bristol Uni and the BRI.

The open plan living space is generous in size and bright thanks to a full height window.

The kitchen consists of a range of white gloss wall and base units, laminated work surfaces and stainless steel sink. In addition, there is a range of integrated appliances including electric hob, oven, extractor hood and fridge freezer.

All three bedrooms have built in wardrobes and large floor to ceiling windows with the master bedroom further benefitting from an en-suite shower room.

A tiled family bathroom completes the accommodation and provides a mains fed shower over bath, basin, low level WC and heated towel rail.

Constructed only 8 years ago, the property and building is still in fantastic condition throughout and has the added benefit of the remainder of the original 10 year new homes warranty.

Location

Dean Street is ideally positioned for access to Cabot Circus with its comprehensive range of high quality stores and individual shops literally across the road, and Bristol Bus Station, Bristol University, and the Bristol Royal Infirmary only a short walk away.

The Centre is the heart of the City with constant action on offer from the Hippodrome and Colston Hall, Bristol Shopping Quarter at Cabot's Circus to the characterful Christmas Steps, Corn Street and St Nicholas Market. Nearby Millennium Square acts as a gateway to the neighbouring harbourside with its fountains and big screen as well as world class attractions such as Brunel's SS Great Britain, We The Curious, Bristol Aquarium, the Arnolfini, Spike Island, the Watershed and the M Shed.

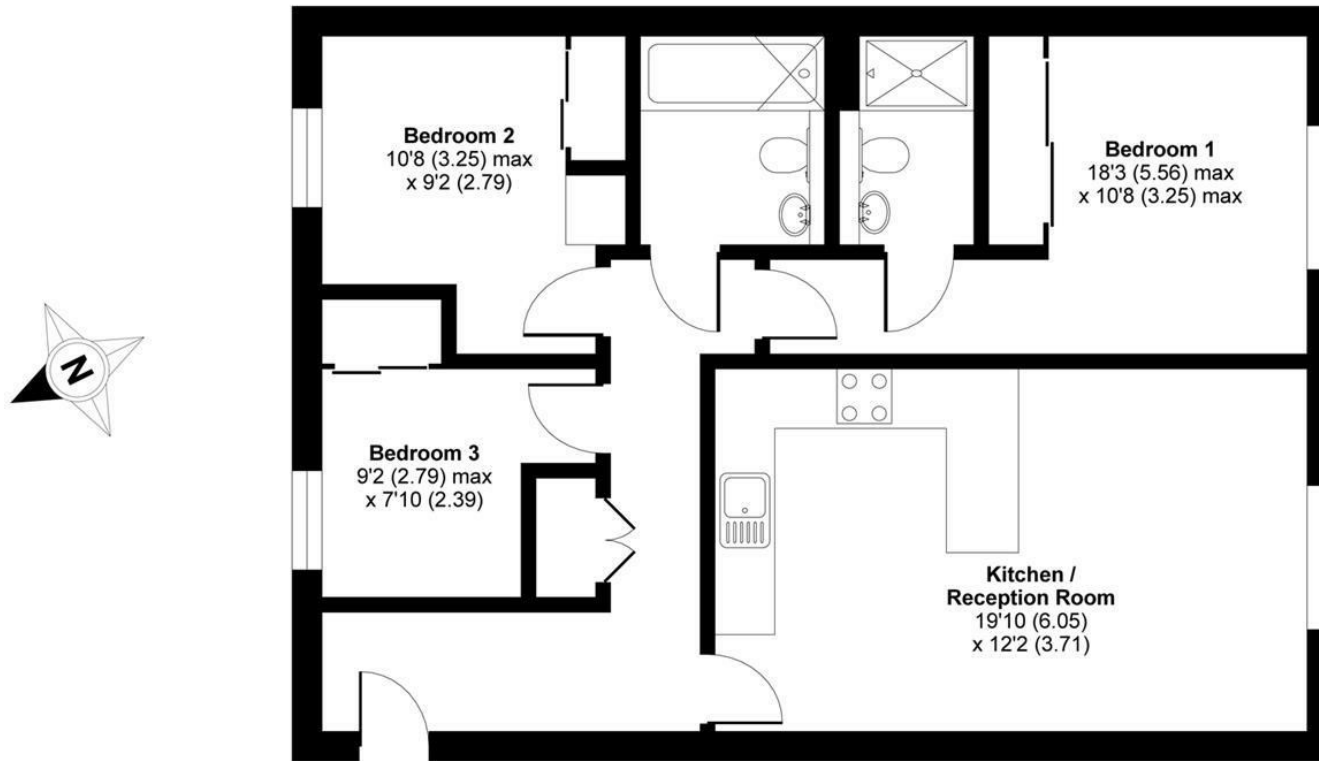
